

New Delhi, July 3: Holding that the right to a speedy trial cannot depend on the severity of the alleged crime, the Supreme Court Wednesday rebuked the National Investigation Agency (NIA) for its delay in prosecuting a counterfeit currency case that resulted in the accused being lodged in jail for four years without trial.

The SC move came while hearing an appeal against a February 2024 Bombay High Court order that denied bail to Javed Gulam

counterfeit currency there. Criticising the delay in the trial, the SC urged the NIA to uphold the right to a speedy trial, rather than 'make a mockery of justice' by seeking time after time to submit its counter affidavit in the matter.

"You are the NIA. Please do not make a mockery of justice. It is four years, and the trial has not commenced. This is not done. Whatever offence the accused has committed, he has the right

to a speedy trial as enshrined

under the Constitution of India.

Law college prof kills dad in City wounds in Sunil's chest and

Bhubaneswar, July 3: Residents of Capital city Wednesday woke up to a spine-chilling murder when an assistant professor of a private law college here allegedly stabbed his father to death over some financial issues at an apartment in Rangamatia area under Mancheswar police limits.

The accused was identified as Anirudha Choudhury, 38, and the victim Sunil Choudhury, 68, a former employee of Nalco, according to the police. Anirudha was under severe mental stress as he was unable to repay a loan of ₹25 lakh he had incurred recently. The accused had frequent quarrels with his father as the latter was not budging to the demand of the former.



Bhubaneswar Deputy Commissioner of Police (DCP) Prateek Singh said Mancheswar police learnt about the incident around 4:30 am and rushed to Flat No-108 of DHPL apartment, Rangamatia. The cops took a profusely bleeding Sunil to Capital Hospital, but the doctors there declared him 'brought dead'.

The stabbing caused deep

stomach, Singh added. Sunil's housekeeper Alok said

the deceased's wife called him around 3am saying her son has attacked her husband with a knife multiple times. "When I reached there, Sunil was lying in a pool of blood, with his son near him. Following this, I called everyone in the flat and apprised them of the situation.

Police sources said there was a bitter quarrel between Anirudha and his wife last week when the latter was seeking some money from him and wanting to dispose of the current flat. Anirudha used to demand money from Sunil to repay loans.

Judicial probe into UP stampede

Lucknow, July 3: Retired judge of Allahabad High Court Brijesh Kumar Srivastav will head the three-member judicial inquiry commission set up by the Uttar Pradesh government Wednesday to probe the Hathras stampede that claimed at least 121 lives, an official statement said.

The commission, tasked to complete the investigation within two months, will look into various aspects of the case including "whether this incident is an accident or a conspiracy" and the arrangements made by the district administration and police for crowd control. It will also recommend preventive steps.

The panel, formed a day after the incident following the direction of Governor Anandiben Patel, will have retired IAS officer Hemant Rao and retired IPS officer Bhavesh Kumar as

its members. It will probe the compliance of the permission granted by the district administration and the conditions mentioned therein by the organisers of the programme.

WORLD'S Japan issues banknotes with 3D hologram

Tokyo, July 3: Japan began circulating its first new banknotes in 20 years Wednesday, featuring three-dimensional portraits of the founders of financial and female education institutions, in an attempt to frustrate counterfeiters. The notes use printed patterns to generate holograms of the portraits facing different directions, depending on the angle of view, employing a technology that Japan's National Printing Bureau claims is the

world's first for paper money. "Faces of those representing Japan's capitalism, women's empowerment and technology innovation are on the new bills, Prime Minister Fumio Kishida said at a function.

The step comes as the economy moves into a growth-driven phase for the first time in three decades, he added.

The new 10,000-ven (\$62) note depicts Eiichi Shibusawa (1840-1931), the founder of the first bank and stock exchange, who is often called "the father of Japanese capitalism"

The new 5,000-yen bill portrays educator Umeko Tsuda (1864-1929), who founded one of the first women's universities in Japan, while the 1,000-yen bill features a pioneering medical scientist, $S\bar{h}$ ibasaburo Kitasato (1853-1931)

While Kishida talked up the latest technology to fight counterfeiting, it is not a major problem in Japan. The 681 fake banknotes police detected in 2023 represented a sharp drop from a record high of 25,858 in 2004.

Authorities plan to print about 7.5 billion newly-designed bills by the end of the current fiscal year, swelling the 18.5 billion banknotes. worth 125 trillion yen, in circulation by December 2023.



'Cash is a secure means of payment that can be used by anyone, anywhere, and at any time, and it will continue to play a significant role" despite alternatives, said Central Bank Governor Kazuo Ueda.

The Bank of Japan has experimented with digital currencies, but the government has made no decision whether to issue a digital yen.

money since 2004 spurred busi-

nesses to upgrade payment ma-

chines for cash-loving customers. Cashless payments in Japan

have almost tripled over the past decade to account for 39 per cent of consumer spending in 2023, but still lag global peers and should rise to 80 per cent to boost productivity, the government says.

Nearly 90 per cent of bank ATMs, train ticket machines and retail cash registers are ready for the new bills, but only half of restaurant and parking ticket machines, the Japan Vending Machine Manufacturers Association said.

Almost 80 per cent of the nation's 2.2 million drink vending machines also need upgrades, it added. "It might take until year-end to respond to this," said Takemori Kawanami, an executive at ticket machine company Elcom. "That's too slow, but we are short of components," he added, as client orders for upgrades exceeded expectations.

Many Japanese fast-food restaurants such as ramen shops and beef bowl stores use ticket machines to cut labour costs, but some small business owners battling inflation are unhappy at the extra investment needed.

"The machine replacement has no sales impact, so it's only negative for us, on top of rising costs of labour and ingredients,' said Shintaro Sekiguchi, who spent about 600,000 yen for ticket machines at three ramen shops he runs in Tokyo.

400 e-buses to be added under PM e-Bus Sewa

be renamed as 'Ama Bus'. The 'Mo Bus' service is providing convenient, sustainable, safe commuting options to the citizens, said the minister, adding that there shall be detailed discussion with the regular passengers.

"The number of buses will be increased based on the need of the citizens. We are checking the situation at various places. The bus service will be providedwherever necessary," Mahapatra asserted.





The Law ministry also announced the appointment of Justice Muhamed Mustague Ayumantakath, a judge of the Kerala High Court, to be the acting chief Justice of that High Court with effect from July 5 as incumbent Chief Justice Ashish Jitendra Desai demits office Thursday on attaining the age of 62 years.

New Delhi, July 3: The Supreme Court has termed as 'incorrect' an order of the Orissa High Court which limited the period of bail granted to

an accused in a case lodged under the Narcotic Drugs and Psychotropic Substances (NDPS) Act to two months.

A vacation bench of Justices JB Pardiwala and Ujjal Bhuyan, while referring to a verdict passed earlier by the top court, said it is now well settled that the right to speedy trial is recognised as a fundamental right

guaranteed by the Constitution and is closely tied to the right to life and personal liberty.

The bench noted that the petitioner had filed a bail application in the High Court which had taken notice of the fact that the petitioner was in custody since May 11, 2022 and only one witness was examined so far.

"In such circumstances, the High Court thought it fit to order release of the petitioner on bail

CONG'S THREE-DAY ULTIMATUM TO COPS

Bhubaneswar, July 3: The Congress Wednesday gave a threeday ultimatum to Odisha Police to arrest the people involved in the alleged attack on its workers in front of the party's state headquarters here Tuesday evening.

Notably, the supporters of both the BJP and the Congress clashed here Tuesday evening during a protest over remarks made by Leader of Opposition Rahul Gandhi in the Lok Sabha.

Speaking to media here, senior Congress MLA Taraprasad Bahinipati said police should arrest the persons involved in the attack on the Congress Bhawan within three days. Otherwise, 20,000 youths will forcibly enter the state BJP office here, he warned.

Under the instruction of the state BJP president and Chief Minister, their party youths hurled stones at Congress headquarters. Several Congress workers and mediapersons were injured during the attack, he alleged.

After coming to power, the BJP government is trying to murder democracy like the BJD. Bahinipati said. He also said that protests will be organised before SP offices across the state if the persons concerned are not arrested in 72 hours.

The incident happened outside Congress Bhawan, where the BJP was holding a demonstration over Rahul's remarks.

Srimandir deities recover from fever

Puri, July 3: A delegation of Daitapati and Pati Mahapatra servitors Wednesday informed Gajapati Dibyasingha Deb about the recovery of Lord Jagannath and His siblings, Lord Balabhadra and Devi Subhadra, from fever in the Anasar Gruha (sick room) of Srimandir.

The servitors went to Sri Nahar (the royal palace) located alongside the Grand Road near the 12th century shrine in a ceremony called 'Rajprasad Bije'.

They said that after the administration of Phuluri oil and Dasmula Aushadhi, the deities are recovering. The sibling deities have changed their clothes from white to coloured ones and have been made to sit on platforms called 'Chaka Bije'. The deities would be ready to ride respective chariots to the Gundicha temple on a nine-day sojourn starting July 7, the delegation said.

The deities had been in the sick room, supposedly suffering from fever after the grand bath on the Snana Purnima. They were put on a fruit diet while the temple Vaidya (physician) treated them with herbs and oils. At the same time, Daita servitors carried out some secret rituals at the Anasar Ghuha.

Since July 7 will witness a rare scenario after five decades when the Netra Utsav, Nabajouban Darshan and Rath Yatra will be observed on a single day, the Gajapati advised the servitors to work dedicatedly to ensure that all the rituals are observed on time as per the prescribed schedule.

"We are glad that President Droupadi Murmu will witness the Rath Yatra of Lord Jagannath and His siblings this year," he

This will be the first such occasion when the President will participate in the Rath Yatra, the Gajapati said.

Highlighting that Justice Arijit Pasayat Committee is expected to have its meeting July 5, he said the initiative to open the inner Ratna Bhandar (inner treasury compartment) of the temple may be taken.

Low rainfall, high CO2 may replace biodiversity hotspots

ven as greenhouse gasses are increasing unprecedentedly, it can decrease rainfall in the equatorial region as well as affect India's biodiversity hotspots, according to a new study Wednesday.

The study showed that it will potentially replace India's biodiversity hotspots consisting of evergreen forests in the Western Ghats, northeast India, and the Andamans with deciduous

For the study researchers from Birbal Sahni Institute of Palaeosciences (BSIP), an autonomous institute of the Department of Science and Technology, used fossil pollen and carbon isotope data from the Eocene Thermal Maximum 2 (ETM-2), also known as H-1 or

It is a period of global warming that occurred around 54 million years ago.

In addition to global warming, during this period the Indian plate also lingered near the equator during its journey from the southern to northern hemi-



"This makes the Indian plate a perfect natural laboratory that offers a peculiar opportunity to understand the vegetation-climate relationship near the equator during the ETM-2," the researchers said.

Based on the availability of fossils from ETM2, the team selected the Panandhro Lignite Mine of Kutch in Gujarat and collected fossil pollen from

Their findings, published in the journal Geoscience Frontiers. found that when atmospheric carbon dioxide (CO2) concentration was more than 1000 parts per million by volume (ppmv) near the palaeo-equator, the rainfall decreased significantly. It led to the expansion of deciduous forests.

The study also raises important questions about the survival of equatorial/tropical rainforests and biodiversity hotspots under increased carbon emissions.

It can also help understand the relationship between CO2 and hydrological cycle and aidin the future conservation of biodiversity hotspots.

Ants perform life-saving amputations on injured mates

RESEARCH ON CARPENTER ANTS PROVIDES FIRST EXAMPLE OF A NON-HUMAN ANIMAL SEVERING LIMBS OF INJURED COMRADES TO CURB INFECTIONS

ew research shows that some ants perform limb amputations on injured comrades to improve their survival chances. The behaviour was documented in Florida carpenter ants - scientific name Camponotus floridanus - a reddish-brown species more than half an inch (1.5 cm) long inhabiting parts of the southeastern United States.

These ants were observed treating injured limbs of nest mates

using their mouthparts or by amputation through biting off the damaged limb. The choice of care depended on the injury's location. When it was further up the leg, they always amputated. When it was further down, they never amputated.

"In this study, we describe for the first time how a non-human animal uses amputations on another individual to save their life," said entomologist Erik Frank of the University of Wurzburg in Germany, lead author of the research published on Tuesday in the journal Current Biology.

"I am convinced that we can safely say that the ants' 'medical system' to care for the injured is the most sophisticated in the animal kingdom, rivaled only by our own," Frank added.

This species nests in rotting wood and defends their home



vigorously against rival ant

"If fights break out, there is a risk of injury," Frank said.

The researchers studied injuries to the upper part of the leg, the femur, and the lower part, the tibia. Such injuries are commonly found in wild ants of various species, sustained in fights,

while hunting or through predation by other animals.

The ants were observed in laboratory conditions.

"They decide between amputating the leg and spending more time caring for the wound. How they decide this, we do not know. But we do know why the treatment differs," Frank said.

It has to do with the flow of hemolymph, the bluish-greenish fluid equivalent to blood in most invertebrates.

"Injuries further down the leg have an increased hemolymph flow, meaning that pathogens already enter the body after only five minutes, rendering amputations useless by the time they could be performed. Injuries further up the leg have a much slower hemolymph flow, giving enough time for timely and effective amputations." Frank said.

In either case, the ants first cleaned the wound, likely applying secretions from glands in the mouth while also probably sucking out infected and dirty hemolymph. The amputation process itself takes at least 40 minutes and sometimes more than three hours, with constant biting at the shoulder.

With amputations after an upper leg injury, the survival rate documented was around 90-95 per cent, compared to about 40 per cent for unattended injuries. For lower leg injuries, in which just cleaning was performed, the survival rate was about 75 per cent, compared to around 15 per cent for unattended injuries.

Wound care has been documented in other ant species that apply an antibiotically effective glandular secretion to injured nest mates. This species lacks that gland.

Ants, which have six legs, are fully functional after losing one. It was female ants observed doing this behaviour.

"All worker ants are female. Males play only a minor role in ant colonies - mate once with the queen and then die," Frank

Berhampur Assembly segment under Berhampur Lok Sabha constituency has witnessed 16 Assembly elections from 1951-52 to 2019 but the mainstream parties in the state have never fielded a candidate from the Telugu community.

However, the ruling BJP fielded a candidate from Telugu community for the first time in the 2024 elections and created history. BJP candidate K Anil Kumar defeated his nearest BJD rival by over 18,000 votes and was elected to the state Assembly.

This has spread cheers among the members of Telugu community as they hoped that Kumar will try to fulfil their demands after his election to the state

Sources said that a team from Andhra Pradesh Legislative Council visited Berhampur, January 23, 2021. The team led by the then chairman of the Legislative Council Mohammed Ahmed Sarif also comprised members of Telugu Language and Culture Committee in Andhra Pradesh.

They also tried to know the state government's attitude towards the members of Telugu community and visited Telugu schools in the city in the presence of state government officials. The members of the Bibardhini Samajam then submitted a 10point charter of demands to the members of the Andhra's Legislative Council team.

Their demands include opening of an Odia-Telugu translator centre in Berhampur and establishment of a Telugu chair in Berhampur University. They also urged the committee members to place their demands before the state government.

Later, the team members visited Bhubaneswar and held talks with the state government. They returned to Andhra Pradesh and urged their own government to press for fulfilment of the demands with the Odisha government

Ten months later, the then Andhra CM visited Bhubaneswar and held discussions with the then Odisha CM in this regard, November 2021 The two Chief Ministers agreed and decided for establishment of a Telugu chair in Berhampur University in keeping with an Odia chair at Ambedkar University in Srikakulam of Andhra Pradesh.

Since then, three and half years have passed but the chairs are yet to be established in both the universities. The establishment of an Odia-Telugu translator centre and introduction of BEd course in Telugu language are yet to materialise.

Steel City girl placed in IBR for painting sibling deities on seeds

Rourkela, July 3: Lord Jagannath's blessing and an indomitable passion to do something different with 21 types of seeds have catapulted a Steel City girl into the India Book of Records (IBR)

The inspiring feat of 15-year-old Smrutirekha Nayak, a Class X student of Chinmaya Vidyalaya in Rourkela, is really commendable and her achievement is a testament to the fact that a human being's creativity can create wonders on anything, even something as mundane and small as seeds. However, Smrutirekha thoughtfully attaches a great philosophy with her idea as she chose 21 different varieties of seeds to paint them with devotion and transformed those from mundane to divine with her art.

"I chose seeds because a seed is the basis of life, something which carries life in it. And Lord Jagannath is the seed of our life. So, I thought



what could be better than this," she explained the philosophy behind her creation.

Poised with this philosophy, Smruti got down to the daunting task of creating the pictures of the sibling deities -- Jagannath, Subhadra and Balabhadra, on 21 types of seeds. "For 16 hours I worked relentlessly without any break to create these 21 images of different sizes, starting from 0.3 cm to 0.8 cm length," she said over phone from her residence at Chhend. "I used seeds of black gram, lemon, pumpkin, coriander and others," she added.

She went to Puri and as per her own admission; she perhaps got a divine calling and suddenly thought about approaching the IBR. "It was a sort of pilgrimage. I watched the trinity inside the temple and I found myself completely lost. After that I met the priests and showed them my artworks and they were also astonished."

"I waited for some time after sending the video of my creation to IBR as there was no reply. I got a reply from them June 27 confirming my selection and soon I got the certificate and other gifts from IBR.

She gave credits to her parents, to those who encouraged her and also the Lord himself. "It was the blessings of the Lord that I have got the award," she said.

New Battlefield

ATO's July summit in Washington marks the 75th anniversary of the alliance's establishment, and it comes at a critical juncture. As threats to global stability evolve beyond conventional military domains, NATO must confront the barrage of disinformation undermining its unity and values. Specifically, member countries must prevent hostile authoritarian regimes from manipulating public opinion by leveraging technology to wage "cognitive warfare."

Fittingly, the upcoming summit is expected to focus on the war in Ukraine and the need for NATO's collective-defense framework to adapt to the realities of today's information ecosystem. Russia's brutal war of aggression has revealed the scale of the threat posed by cognitive warfare, with the Kremlin orchestrating a massive social-media campaign aimed at spreading false narratives, fueling anti-Western and anti-democratic sentiment, and undermining NATO's greatest strength: its unity.

To be sure, information warfare is not new. During the Cold War, NATO recognised and countered the Soviet Union's efforts to use propaganda and disinformation to weaken Western democracies. Since then, however, the digital revolution and subsequent rise of artificial intelligence have compounded the problem, enabling bad actors to produce and disseminate deepfakes and other forms of AI-augmented

content at unprecedented speed and scale. While these powerful new tools can yield significant economic benefits, they can also be dangerous weapons. Hostile powers like Russia are already using disinformation against democracies to influence domestic public debate, drive polarisation, erode trust in institutions, and weaken their ability to address shared challenges. This super election year, with half of the world's population casting ballots, creates a unique opportunity for NATO's adversaries to undermine democratic processes and fuel political instability.

NATO countries must confront the threat of AI-augmented disinformation head-on. This requires moving beyond the current reactive approach, which focuses on debunking falsehoods. The alliance must develop a comprehensive collective-defense doctrine that treats the information ecosystem as a key front in the battle to protect democratic societies.

Several key changes are needed. First, NATO must develop the capability to monitor and analyse disinformation in real time. Investing in open-source intelligence (OSINT) tools and collaborating with tech companies is crucial to developing the nec-

essary technical expertise to identify and counter malign influence campaigns. Specifically, NATO must invest in content authenticity and transparency tools - such as large language models (LLMs), AI classifiers, and natural language processing for sentiment analysis – that can identify AI-generated or altered content.

Second, countering disinformation effectively requires fast, agile, and far-reaching strategic communications. To this end, NATO must proactively promote its interests and mission, highlight the failures of authoritarian regimes, and offer its own positive narrative

But to do this effectively, NATO must also take the battle to its adversaries' information ecosystems. By actively highlighting the malign activities of authoritarian regimes on their own digital platforms, NATO could undermine autocrats' narratives and expose their tactics. At the same time, amplifying independent voices in these domains could create a powerful multiplier effect, fostering greater resilience against propaganda and disinformation.

Third, because disinformation campaigns transcend national borders, countering them will require NATO to establish collaborative relationships with governments, private companies, and civil-society organisations. These partnerships should focus on developing shared standards, early-warning systems, coordinated responses to massive disinformation campaigns, and mechanisms to trace and mitigate malign activities across multiple sovereign information environments. As the concerted effort to combat Russian disinformation about Ukraine demonstrates, continuous collaboration is vital.

Lastly, the best defense against disinformation consists in fostering informed, critical-thinking populations. By supporting programmes that promote media and digital literacy, like those already in place in Finland, NATO could help build societal resilience against propaganda and voter manipulation.

To implement this strategy, NATO will also require new organisational structures. For starters, the alliance should establish a disinformation unit responsible for coordinating intelligence, spearheading countermessaging efforts, and building strategic partnerships. Such a unit could leverage the Five Eyes intelligence alliance (the United States, the United Kingdom, Australia, New Zealand, and Canada), as well as the work of Europol - the European Union's law-enforcement agency - to bolster and expand information-sharing networks.

Given the threat posed by the emerging "axis of disruptors" – comprising China, Russia, Iran, and North Korea – NATO must combine its military prowess with equally sophisticated mechanisms to protect its members' information systems against cognitive warfare. Member countries should use the upcoming Washington summit to make this approach a top priority. Confronting disinformation is not just about protecting the integrity of public debate; it is also about defending the very foundations of freedom and security. It is an opportunity we cannot afford to miss, because what is at stake is a battle we cannot afford to lose.

DUE TO THEIR LARGE SIZE OF POPULATION, THE HINDUS IN **BRITAIN HAVE BEGUN TO WIELD CONSIDERABLE ELECTORAL INFLUENCE IN BRITISH POLITICS**

4 July UK Parliament election is significant from several dimensions which may have strong impact on India and UK relations. The British Labour Party is expecting to seize power from the Conservatives after suffering four consecutive defeats. But even in the United Kingdom, poll predictions have gone dramatically wrong. From the Indian point of view, the diaspora has become for the first time hyperactive with Hindus of Indian origin having their own manifesto. Also, the incumbent government is led by Rishi Sunak, a first non-white Prime Minister of UK. Incidentally, he also openly proclaims his Hindu identity.

Another important development for India is that India-UK Free Trade Agreement (FTA) is part of election manifestos. London has also been trying to revive the Commonwealth which consists of the former colonies of the UK. Amongst them, India is the biggest and the largest economy. Recall that British colonialism used to treat India as its 'jewel in the crown'. So, the FTA is expected to be taken forward by any party coming to power from the 5th of July.

Unarguably, the issues mainly related to India merit some analysis. The Indian Diaspora is about 1.8 million, out of which 1.06 million are Hindus as per 2021 Census. Hinduism is now the third largest religion in England. Due to their large size of population, the Hindus in Britain have begun to wield considerable electoral influence in British politics. Their manifesto, "Hindu Manifesto UK 2024" has been jointly prepared by a coalition of 29 Hindu groups like BAPS Swaminarayan

Sanstha UK, Chinmaya Mission, and ISKCON UK. It has also received the support from several parliamentary candidates.

What does the Hindu manifesto consist of? It has seven key demands. These are: protection of Hindu places of worship, access to fair education. equal representation, streamlined immigration, health and social care, protection of dharmic values and recognition of anti-Hindu hate as a religious hate crime. Basically, the manifesto aims to unify the UK Hindu community's voice urging all parliamentary candidates to support the community.

Fast forward, in 2017 general elections, eight Hindu MPs were elected to the British Parliament which was an all-time high reflecting the community's increasing political clout. The highest point so far was the election of Rishi Sunak as the Prime Minister in 2022. Although, the Hindu leaders in the UK will be driven by the national interest of the country.

they could, to a great extent, contribute to the cultural diplomacy between the two countries which in turn enhances bilateralism. Reassertion of Indian traditions and culture, largely through reiteration of Hindu identity at the behest of the ruling BJP may have spurred the activism of Hindu leaders in the UK. At any rate, Diaspora of any ethnicity in any country feels somewhat nostalgic about the country of their origin.

As said, FTA with India is on the manifesto of both Tory and the Labour. Both sides would like to conclude it in mutual interests of both countries. Due to India's prolonged election process covering one-and-half month and seven phases, and campaigning in Britain the 14th round of negotiations have been stalled. The negotiations had begun in January 2022 under the premiership of Boris Johnson. Since then, the Tories have been bedevilled by the leadership crisis.

Now the Conservative manifesto reads, "We will finalise a Free Trade Agreement with India, alongside a deeper strategic partnership on technology and defence.

The Labour Party has gone a few steps further on FTA. Their manifesto states, "We will seek a new strategic partnership with India, including a Free Trade Agreement, as well as deepening cooperation in areas like security, education, technology and climate change".

The British Indians are not a politically coherent community and not without any controversies including moral turpitude. But as a Diaspora, they are perceived as a significant political community. How to use this connection in India's foreign policy is a question to be addressed by diplomats in South Block.

Remember, India could have a formal relation with the European Union only after Britain joined it in 1973, although, New Delhi had made political contact with the Union since 1962. Once, when I was trying to be nominated to an international body, the Swedish friends suggested that I should have the backing of the Brits. New Delhi may be making new contacts with other European countries like France but a continued close relation with Britain is important for India. For many Indian students seeking higher studies, Britain is still a preferred destination. Many Indians would like to go to Britain and work. This helps relocating the huge Indian population. So, whatever happens in the election on 4 July, New Delhi ought to keep in mind the issues debated in the campaign.

One reads of individuals who are lynched on the suspicion of consuming this forbidden meat frequently in our polarised environment. Considering such sentiments, the burden of tracing the trajectory of this practice and its sanctity falls upon dispassionate

historians and writers. Archaeologist BB Lal, in his book "The Rigvedic People," reports on the archaeological evidence of meat consumption in the Indus Valley sites. That Bos indicus, or the Indian humped cattle, was consumed is proved by fragments of charred bones and evidence of cuts by sharp instruments. Lal also finds evidence of consumption of cattle at the Hastinapur sites, where the legendary Mahabharata is set. Lal was not ideologically motivated. In fact, Lal was accused of being sympathetic to the Hindutva cause for his excavation at the Babri mosque site. Later in his life, the Vajpayee government awarded him with Padma Bhushan while the Modi government honoured him with

Padma Vibhushan.

The "Hinduness" of the inhabitants of Indus Valley civilization can still be debated. The archaeological evidence, nevertheless, are corroborated by scriptural evidence. The Rig Veda frequently refers to animal sacrifice, particularly oxen for Indra. The Taittireya Brahmana considers the immolation of "heifers" to be an important feature of rituals associated on the new moon days. The text further elaborates on the method of cutting up the animal and distribution of its meat, thus making it implicit that the animal is for consumption.

In Rig Veda, Agni is referred to as one whose food is the ox and "the barren cow." The Shatapatha Brahmana (III. 1.2.21) refers to sage Yainavalkva willing to consume the meat of Ox and cows provided it was tender. This text also declares meat to be the best kind of food. As the Sanskrit scholar and devout Hindu Bharat Ratna Pandurang Vaman Kane has noted, the offering of cows as sacrifice existed alongside its sacredness. VD Savarkar, the Hindutva ideologue and social reformer, castigated the orthodoxy heavily for worshipping an "animal that lies in its own filth." In his usual sardonic tone, Savarkar attacks cow worshippers who "filled their cupped palms with cow urine and sprinkled it all over a temple but if a pure and wise man like Dr. Ambedkar

were to give them Ganga water, let alone drinking it, if it were even sprinkled on them, they believe they have been polluted. Swami Vivekananda too considered the taboo against beef to be a mere cultural custom. He treated his disciple Sister Nivedita's brother to a beef-steak dinner in London, Vivekananda mentions that Brahmins consumed beef in ancient India. In his words: "There was a time in this very India when, without eating beef, no Brahmin could remain a Brahmin: vou read in the Vedas how, when a Sannyasin, a king, or a great man came into a house, the best bullock was Furthermore. killed. Vivekananda says that according to ancient rituals, "a man cannot be a good Hindu who does not eat beef." In the same passage, decrying the injunctions against beef as optional and temporary, Vivekananda hints at the flexibility of caste by arguing that caste in contemporary age ought to be "dispensed with." Decades after, Ambedkar would scholarly probe the connections between beef eating and caste.

Ambedkar starts his critique by referring to the Census of 1910, which found that the untouchables consumed the dead cow as one of their chief sources of food. Surveying the scriptural texts of Hinduism and Buddhism. Ambedkar proves indisputably that touchable Hindus, including Brahmins ate beef in the past.

The non-Brahmin could have given up the consumption of beef to imitate the hierarchically su-___ perior Brahmins. What led to the Brahmin giving up beef? The Aitareva Brahmana not only describes ritual sacrifice but also prescribes methods of butchering by Brahmin, Ambedkar postulates that it was the conflict between Brahminism and Buddhism. which compelled Brahmins to give up ritual sacrifice of the agriculturally useful cow in the face of Buddhist condemnation. This is one of the many plausible hypotheses that attempts to resolve this age-old question.

All these facts together merely elucidate the nuances of the debate concerning the historicity and the ritual sanctity of the cow. Should one condemn great individuals like Vivekananda. Savarkar and Ambedkar as anti-Hindu or averse to Indian culture merely because they did not see value in an artificial ritual? Is Indian culture or "Bharatiyata" so narrow that it cannot accommodate an individual with different dietary habits? Is our path to progress being impeded by our tendency to legislate personal religious beliefs? These are questions I leave the reader to ponder over.

There have been a number of stampedes in India over the last some decades, as many religious events are organised without adequate preparations, and proper safety measures in place. The role of authorities and their utter failure and negligence to manage huge crowds primarily cause such stampedes. While the National Disaster Management Authority (NDMA) had released guidelines in 2014 for crowd management, these directions are flouted with impunity. By ensuring separate entry and exit points at a location, deploying adequate police and security personnel and using a public address system to dispel rumours and any other communication, stampedes can be prevented, saving precious human lives.

The Chief Minister reviewed the situation in Garal Bhattapara Gaonburah ghat and also inspected the Dharapur Jangrabari Sluice Gate over River Khana.

He reassured residents of repair work on damaged embankments and roads, alongside provisions of food and medical aid in relief camps.

The current second wave of floods have affected Barpeta, Biswanath, Cachar, Charaideo, Chirang, Darrang, Dhemaji, Dibrugarh, Golaghat, Jorhat Kamrup Metropolitan, Karbi Karimganj, Lakhimpur, Majuli, Morigaon, Nagaon, Nalbari, Sivasagar, Sonitpur, Tamulpur, Tinsukia and Udalguri districts.

Meitei, Naga bodies in Manipur urge Guv to implement NRC to curb illegal influx

Imphal, July 3: Leading Meitei and Naga community organisations Tuesday jointly urged Manipur Governor Anusuiya Uikey to implement the National Register of Citizens (NRC) in the state to curb infiltration from across the border and protect the indigenous people.

Raj Bhavan officials said that leaders of the Coordinating Committee for Manipur Integrity (COCOMI) and the United Naga Council (UNC) jointly urged the Governor to implement the NRC with a base year of 1951. COCOMI Coordinator

Thokchom Somorendro and UNC President NG Lorho led the joint delegation, which also submitted a memorandum to the Governor.

COCOMI is the apex body of the Meitei community in Manipur while the UNC is the leading organisation of Nagas in the state.

Somorendro and Lorho informed the Governor that NRC implementation in Manipur is extremely vital to curb the influx of illegal immigrants, which they claimed, "shattered the demographic imbalance" of the northeastern state.

"Illegal migrants have already caused serious uncertainties and political insecurities to the native population of the state," the memorandum said.

The COCOMI and UNC leaders have urged the Governor that NRC should be implemented at the earliest so that scientific method of identification may be applied to detect illegal immigrants and ensure that no further infiltration occurs in the state henceforth.

"Random village recognition without verification must be stopped. They further mentioned that the abnormal increase of villages in specific districts should be examined and corrective measures must be taken up," they said.

Raj Bhavan officials said that the Governor assured the leaders of the two prominent organisations that necessary steps

would be taken to ensure the NRC was implemented in the state and it is just a matter of



NEET-UG LEAK CASE CBI arrests co-conspirator from Dhanbad

New Delhi, July 3: The CBI arrested an alleged co-conspirator in the NEET-UG paper leak case, Aman Singh, from Dhanbad in Jharkhand, officials said Wednesday.

The CBI has developed intelligence about Jharkhandbased module allegedly involved in the paper leak that resulted in the arrest of Singh, they said.

The agency had earlier arrested principal and vice principal of Hazaribagh-based Oasis school in the case and two persons who allegedly provided safe premises to NEET candidates where burnt question papers were recovered by Bihar Police, the officials said.

The CBI has registered six FIRs in the case. The FIR from Bihar pertains to leakage of paper while remaining from Gujarat and Rajasthan pertains to impersonation of candidates and cheating.

The agency's own FIR on a reference from the Union Education Ministry pertains to a "comprehensive investigation" into alleged irregularities in the medical entrance examination. NEET-UG is conducted by

the National Testing Agency (NTA) for admissions to MBBS, BDS, AYUSH and other related courses in government and private institutions.

This year, the exam was conducted May 5 at 4,750 centres in 571 cities, including 14 abroad. More than 23 lakh candidates had appeared for the test.

Champai resigns; Hemant stakes claim to form govt

Ranchi, July 3: Jharkhand Chief Minister Champai Soren resigned Wednesday and Hemant Soren, who is out on bail in a money laundering case, staked claim to form the government, hours after leaders of the JMM-led alliance in the state unanimously elected him as the legislature party leader. Champai Soren, who had taken

oath as the 12th chief minister of Jharkhand February 2 after Hemant Soren's arrest, met Governor CP Radhakrishnan at Raj Bhavan and tendered his resignation in the presence of the JMM executive president, capping a day-long drama full of speculations.

Hemant Soren staked claim to form the government and the swearing-in ceremony is likely to be held soon. If sworn in, Hemant Soren will be the 13th Chief Minister of Jharkhand, which was carved out of Bihar November 15, 2000.

"I have resigned as per the decision of the JMM-led alliance. Our alliance is strong," Champai Soren said after coming out of

"All know what had happened with Hemant Soren Ji... I was given the responsibility by the coalition partners. Now, the alliance has decided in favour of Hemant Soren Ji," he said. Hemant Soren told the media all formalities to form the government are complete.

SC blasts Manipur govt

New Delhi, July 3: "We do not Supreme Court said Wednesday as it fulminated against the Manipur government over an undertrial prisoner belonging to the minority Kuki community not being taken to hospital for treatment over safety

A bench of Justices JB Pardiwala and Ujjal Bhuyan made some strong observations against the state while hearing a plea filed by Lunkhongam Haokip that he was suffering from piles and tuberculosis and was not taken to hospital by jail officials despite having severe backache.

'We do not trust the state...The accused was not taken to hospital because he is from the Kuki community. So sad! We direct him to be examined now. If the medical report reveals something serious, we will take you to task," the bench said. The counsel for Haokip claimed the jail officials did not pay heed to persistent requests for medical help.

The bench perused an order of the Manipur High Court and found that the undertrial prisoner was not taken to hospital since he was from the Kuki community and "shifting him to a hospital will be hazardous taking into account the law and order situation"

Manipur has been in the grip of an ethnic conflict between the minority Kuki and majority Meitei communities.

The bench directed the jail superintendent and the state authorities "to make necessary arrangements for his transportation to the Gauhati Medical College and get him examined therein. The medical exam shall be as regards piles, TB, tonsillitis, abdominal pain as well as problems in lower lumbar spine".

It sought a detailed medical report on or before July 15 and asked the state to bear all the expenses including the treatment cost.

Manipur descended into chaos and violence in May last year over a high court order directing the state government to consider including the non-tribal Meitei community in the list of Scheduled Tribes. More than 170 people have

been killed and several hundred others injured since ethnic violence first broke out in the state May 3 last year when a 'Tribal Solidarity March' was organised in hill districts to protest against the majority Meitei community's demand for ST status.

Our orders not just for fun: Apex court

New Delhi, July 3: The Supreme Court Wednesday pulled up the Uttar Pradesh government for non-compliance with its order on examination of a minor victim of sexual assault, asserting it does not pass an order "just for fun".

A vacation bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah, which granted the prosecution one week to examine the victim in the Protection of Children from Sexual Offences (POCSO) Act case, warned it would summon the state's home secretary if it was not done within the stipulated time.

'Our order was a mandatory order, it was to be followed in letter and spirit. We are not passing orders just for fun," Justice Amanullah told senior advocate Garima Prasad, appearing for the Uttar Pradesh government. The top court was hearing the



accused of raping the girl.

'We are seeing it happening day in and day out....every state counsel is taking our orders casually. If it is not done within one week, we will call your home secretary here. We are at fault for letting these things happen....the fault is on our part. The message has to go (out)," an annoyed apex court bench said.

Prasad, at the outset, sought adjournment saying the victim's evidence could not be recorded as there was a condolence meet at the trial court. The bench said the state's counsel was very casual in approach. Since it was a "mandatory order", the prosecution should have filed a petition for extension of time.

"Be verv careful in court. Now we are going to take serious note of this. It was your duty to file a proper application for extension of time," it told Prasad and granted a week's time for examining the victim. The accused, who has been booked for alleged rape and criminal intimidation of a 16-year-old girl, has challenged the Allahabad High Court order rejecting his bail plea November 30 last year.

According to the prosecution, an FIR dated September 19, 2023 was lodged against the accused for sexually assaulting the minor repeatedly for over six months.

Earlier, while taking note of the fact that many witnesses in the case had not been examined, the top court had directed that the victim be examined by June 30. The accused had claimed none of the material witnesses had been examined in the case and sought bail.


history, granting her access to his medical records every week was justifiable and essential.



Govt asks states to maintain vigil

New Delhi, July 3: In view of some cases of Zika virus reported from of Maharashtra, the Union Health Ministry Wednesday issued an advisory to all states highlighting the need for maintaining a constant vigil over the situation in the country.

States have been urged to focus on screening pregnant women for Zika virus and monitor the growth of foetus of expecting mothers who tested positive for the infection. Besides the advisory by Director General of Health Services Dr Atul Goel. the ministry also asked health facilities to identify a nodal officer to monitor and act to keep the premises free of Aedes mosquito infestation.

Zika is an Aedes mosquitoborne viral disease like dengue and chikungunya.

Though non-fatal, Zika is associated with microcephaly (a condition where the head is much smaller than expected) in babies born to affected pregnant women which makes it a cause of major concern.

As Zika is associated with microcephaly and neurological consequences in the foetus of the affected pregnant women, states have been advised to alert the clinicians for close monitoring, the advisory stated.

States are urged to instruct the health facilities in the affected areas or those catering to cases from affected areas to screen pregnant women for Zika, monitor the growth of the fetus of expecting mothers who have tested positive for the infection and act as per Central government guidelines.

Poverty in India declines to 8.5% from 21.2%: Report

New Delhi, July 3: Poverty in India is estimated to have declined to 8.5 per cent in 2022-24 from 21.2 per cent in 2011-12, despite the challenges posed by the pandemic, according to a research paper by the economic think tank NCAER.

The paper titled 'Rethinking Social Safety Nets in a Changing Society', authored by Sonalde Desai of NCAER, used data from the newly completed Wave 3 of the India Human Development Survey (IHDS) as well as data from Waves 1 and 2 of the IHDS.

"According to the IHDS findings...poverty declined significantly between 2004-2005 and 2011-12 (from a headcount ratio

of 38.6 to 21.2), and it continued to decline between 2011-12 and 2022-24 (from 21.2 to 8.5) despite the challenges posed by the pandemic," the paper said. The paper said economic growth and poverty decline create a dynamic climate that requires nimble social protection programmes.

Traditional strategies designed to address chronic poverty in a large segment of society may be less effective as accidents of birth become less important than accidents of life, it added. The paper noted that ensuring social protection systems keep up with the pace of social transformation will be a key challenge for India as it strives towards equitable development.

According to the paper, dur-

ing an era of economic growth, when opportunities increase, the long-term determinants of poverty may decline while accidents of life associated with

natural disasters, illness and death, and changes in occupation-specific opportunities may become more important.

"Accidents of birth are more

likely to affect long-term chronic poverty, accidents of life may have a transitory effect on

"If we take the poverty line and inflate it with the Consumer Price Index (CPI) to today's rate, we see that the average consumption of the lowest fractional, the 0-5 per cent, is about the same. This means poverty in the country is there in the 0-5 per cent group only," the NITI Aayog CEO had said. The National Sample Survey

Office (NSSO), under the Ministry of Statistics and Programme Implementation, released data on household consumption expenditure for the year 2022-23 February 24 that showed per capita monthly household expenditure more than doubled in 2022-23 as compared to 2011-12.

The poverty line recommended by the Tendulkar Committee Report was set to ₹447 and ₹579 for rural and urban areas, respectively, but varied between states for 2004-2005. These poverty thresholds were subsequently adjusted by The-Planning Commission to ₹860 and ₹1,000 for 2011-12.



Egypt swears in new Cab

Cairo: Egypt's new Cabinet was sworn in Wednesday as the country faces an ailing economy and raging conflicts in neighbouring nations. Prime Minister Mustafa Madbouly, who was first appointed in 2018, has been again tapped to form the new Cabinet which includes several technocrats. Some ministers, including those in charge of police and tourism, remain in place, but others, particularly defence, foreign affairs and economy-related portfolios, represent major challenges. The ministers have taken the oath before President Abdel Fattah el-Sissi in Cairo.

PM Shehbaz meets Putin

Astana: Prime Minister Shehbaz Sharif Wednesday met with Russian President Vladimir Putin here wherein he emphasised the expansion of bilateral trade between Pakistan and Russia. The prime minister, in his televised opening remarks at the meeting, said the bilateral trade stood at around \$1 billion which could be expanded by overcoming the financial and banking matters. He expressed his readiness to work closely with the Russian president to further cement bilateral ties.

French citizen pleads guilty

Moscow: A French citizen arrested in Russia has pleaded guilty to criminal charges involving illegally collecting information on military issues in the country, state news agency Tass reported Wednesday. Laurent Vinatier was arrested in the Russian capital in June as tensions flared between Moscow and Paris following French President Emmanuel Macron's comments about the possibility of deploying French troops in Ukraine. Under Russian law, the criminal offense is punishable by up to five years in prison.

Toshakhana scam: **Relief for Khan**

Islamabad: A Pakistani court Wednesday acquitted former Prime Minister Imran Khan and several senior party colleagues in a case registered against them for protesting against the jailed Premier's disqualification by the election commission in the Toshakhana corruption case. Harris top choice to replace Biden

Washington, July 3: Vice President Kamala Harris is the top alternative to replace US President Joe Biden if he decides not to continue his reelection campaign, according to seven senior sources at the Biden campaign, the White House and the Democratic National Committee with knowledge of current discussions on the topic.

Biden's fumbling, sometimesincoherent and widely-panned first-debate performance against Republican rival Donald Trump last week set off a wave of panic within the Democratic Party over concerns that he may not be fit enough to serve a second term, and prompted calls for top aides to resign.

Prez debate: Biden admits falling asleep on stage

Us President Joe Biden has admitted that he "almost fell asleep on stage" and "was not very smart" enough to handle his schedule before the first presidential debate with Donald Trump, blaming his extensive foreign travels for his disastrous performance. During their roughly 90-minute debate defined by personal attacks, Trump, the presumptive Republican Party candidate in the November 5 presidential election, clashed right from the start with Biden, arguing pointedly about the American economy, foreign relations

Biden admitted that he did not have a good debate, and apologised by saying that he was

sorry for the performance. "It's not an excuse but an explanation," he said

have floated alternatives to Biden besides Harris, including popular cabinet members and Democratic

governors like Gavin Newsom from California, Gretchen Whitmer of Michigan and Josh

Shapiro of Pennsylvania. But trying to sidestep Harris is wishful thinking and would be nearly impossible, these sources, who did not wish to be named, said.

If named as the party nominee, Harris, 59, would take over money raised by the Biden campaign and inherit campaign infrastructure, the sources said. She also has the highest name recognition among all the alternatives, and the highest polling among Democrats who could seriously be considered a candidate, the sources said.

In addition, she has already been vetted for national office and has survived intense scrutiny from Republicans, they said. Also, US Representative Jim Clyburn, the man who was key to Biden's 2020 win, told MSNBC he would support Harris to be the Democratic nominee if Biden stepped aside.

Harris's aides dismissed any talk of a Democratic ticket that doesn't include both Biden and Harris. "Vice President Harris looks forward to serving a second term with President Joe Biden," a statement from her office said.

The United States has never elected a woman President, and Harris has spent much of her time as vice President struggling to distinguish herself in a role that is by definition a supporting one. As recently as last year, many inside the White House and the Biden campaign privately worried she was a liability for the campaign.

Since then, Harris has managed to find her stride on the issue of abortion rights but her polling has not improved significantly. Harris's approval ratings hover under 40%, but according to recent polling highlighted by the Biden campaign, she and the President have similar odds of beating Trump.

The Vice President has also been consistently targeted by Republicans and conservative media in attacks many allies consider sexist and racist.

Three Democratic donors, who have recently been pushing for Biden to step aside, also said this week they think it will be "impossible" to sidestep Harris. The donors had been floating Whitmer and Newsom's names as possible alternatives until the past weekend.

There is a real conversation in the Democratic party about leadership right now, but fair to say, and I'm not thrilled about this, it will be impossible to ignore Kamala," said one of the donors. Another donor said "she's nobody's choice, but yeah, nearly impossible.

Still, the President's reelection campaign is standing its ground, emboldened by a stronger performance by Biden during a scripted speech in North Carolina even as calls for him to step aside grow.

Employer held for Indian worker's death in Italy

Rome, July 3: Italian police have arrested the owner of the agriculture company who dumped a 31-year-old Indian worker on the road without medical assistance after his arm was severed by heavy farm machinery, causing his death, a tragic incident that shocked the country and its leadership.

Satnam Singh was abandoned by his employer after a strawberry wrapping machine severed his arm in Lazio, near Rome, last month and died due to "copious bleeding", the ANSA news agency reported.

The Sikh casual farm labourer died in a hospital in Rome two days later after being airlifted there when he was eventually found.

Police Tuesday arrested the alleged gangmaster, Antonello Lovato, on suspicion of causing Singh's manslaughter death, the report said. Prosecutors said in a state-

ment that the Sikh farmer, who died of a massive haemorrhage in a Rome hospital, "would in all likelihood have been saved if he had been promptly assisted". "We were waiting for this news,

we were angry," the President of the Lazio Indian community, Gurmukh Singh, said.

"The worst thing (Lovato) did was to leave him outside his home instead of taking him to hospital," he was quoted

Nepali Congress urges PM Prachanda to quit

The Israeli group Peace Now said Wednesday that authorities recently approved the appropriation of 12.7 sq km of land in the Jordan Valley. The group's data indicate it was the largest single appropriation approved

Sebi cuts face value of debt securities

New Delhi: Markets regulator Sebi Wednesday drastically cut the face value of debt securities to ₹10,000 from ₹1 lakh at present to boost participation of retail investors in the corporate bond market. Market participants are of the view that lower ticket size of debt securities may encourage more non-institutional investors to participate in the corporate bond market which in turn may also enhance liquidity. In a circular, Sebi said, "the issuer may issue debt security or non-convertible redeemable preference shares on private placement basis at a face value of ₹10.000". This, however. would be subject to certain conditions like the issuer should appoint at least one merchant banker, and nonconvertible debentures and non-convertible redeemable preference shares are plain vanilla, interest or dividendbearing instruments.

Govt bonds worth ₹28K-cr on sale

New Delhi: The Finance Ministry on Wednesday announced the sale of Government bonds worth ₹28,000 crore in three lots through auctions to be conducted by the Reserve Bank of India in Mumbai on Friday (July 5). The first lot comprises 7.02 per cent **Government Security 2027** for a notified amount of ₹6,000 crore. The second set of 7.23 per cent Government Security 2039 is valued at ₹12,000 crore while the third lot of 7.30 per cent **Government Security 2053** are for a notified amount of ₹10,000 crore. The three lots will be sold through a price-based auction using the multiple price method.

Wheat procurement crosses last yr's buy

New Delhi: The Food Corporation of India (FCI) has procured 26.6 million tonne of wheat during the current Rabi Marketing Season (RMS) 2024-25, surpassing last year's figure of 26.2 million tonne, the government said Wednesday. The procurement, which began earlier than usual this year, has benefited more than 2.2 million farmers who received about ₹61 lakh crore directly in their bank accounts as payment at the Minimum Support Price (MSP), it said in a statement. The government had set the MSP for wheat at ₹2,275 per quintal for the current season (April-March). States like Uttar Pradesh and Rajasthan showed significant improvements in their wheat procurement, the statement said.

Curtains down for India's X rival Koo

New Delhi, July 3: Social media platform Koo, which had pitched itself as a rival and viable alternate to Twitter (now X), is shutting down with co-founders Wednesday penning a heartfelt note about tough decisions and little yellow bird bidding "final goodbye"

Startups raised nearly \$7bn in H1

New Delhi, July 3: Indian startups have raised nearly \$7 billion in funding during the first half (H1) of 2024, more than the \$5.92 billion raised in H1 2023.

However, the figures are still far less than \$20 billion in H1 2022, according to data compiled by TheKredible.

The \$7 billion funding included 182 growth or late-stage deals worth \$5.4 billion and 404 earlystage deals worth \$1.54 billion. About 99 were undisclosed deals, reports Entrackr.

During H1, Indian startups produced a couple of unicorns Perfios and Krutrim SI Designs. Last year, only two startups managed to cross the unicorn valuation while 2022 and 2021 witnessed the emergence of 26 and 44 unicorns, respectively.

When it comes to month-onmonth trends, June witnessed nearly \$2 billion in funding which is more than double the average of \$1 billion monthly funding until May this year, the report mentioned.

Late-stage companies such as Zepto, Flipkart, PharmEasy and Lenskart topped with \$665 million, \$350 million, \$216 million, and \$200 million funding, respectively. Robust increase in new business. exports in June, says PMI

New Delhi, July 3: India's services sector growth quickened in June from May's five-month low, amid a stronger rise in new orders and an unprecedented expansion in international sales, a monthly survey said Wednesday.

The seasonally adjusted HSBC India Services Business Activity Index rose from 60.2 in May to 60.5 in June, pointing to a sharp expansion in output.

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"Activity growth in India's service sector accelerated in June. with the index rising by 0.3 ppt (percentage point) to 60.5, led by an increase in both domestic and international new orders. This encouraged services firms to increase their staffing levels at the fastest pace since August 2022, said Pranjul Bhandari, Chief India Economist at HSBC.

Demand strength and rising intakes of new business were cited as the key determinants of growth. New orders received by Indian service providers continued to increase in June, extending the current sequence of expansion to nearly three years.

There was also a record expansion in international orders. Asia, Australia, Europe, Latin America, the Middle East and the US were all cited as sources of new work from abroad.

Positive client appetite encouraged service providers in India to recruit additional staff at the end of the first fiscal quarter. Staffing levels increased at the fastest pace since August 2022, as short-term and perma-

port pipelines of new work. On the price front, service providers recorded a moderate increase in their average expenses due to higher food, fuel and labour costs. The pace of inflation was nevertheless the weakest in four months. Subsequently, selling prices also rose at the

The CAC, an international body established by FAO and the World Health Organization (WHO), aims to protect consumer health and promote fair practices in food trade. The executive committee plays a critical role in reviewing proposals for new work and monitoring the progress of standards development.

India also backed the progression of standards for named vegetable oils, guidelines for the control of Shiga Toxin-Producing Escherichia coli, and the safe use and reuse of water in food production and processing.

Mumbai, July 3: The near-simultaneous tariff hikes of over 20 per cent by the country's top three telcos will push up core inflation by 0.20 per cent in FY25, a foreign brokerage said

Analysts at Deutsche Bank also upped their core inflation or the price rise, excluding food and fuel, by 0.20 per cent to 3.8 per cent.

Apart from the tariff hikes, the below-trend monsoon rains will be another factor that will be of focus from an inflation trajectory perspective, they said.

The report said the impact of telecom tariff hikes will start getting reflected from July, and the hikes will alone push the monthon-month core inflation by over 0.85 per cent month on month.

"Overall, core inflation will likely rise by 0.20 per cent in FY25 due to the telecom tariff hikes. Consequently, we revise our FY25 core inflation forecast to 3.8 per cent, from 3.6 per cent average earlier," they added.
