Berhampur: The toll in the Ganjam hooch tragedy rose to four as a 60year-old man who was under treatment at MKCG Medical College Hospital here after consuming spurious liquor died Sunday, police said. The deceased was identified as Baya Sethi of Karabalua village near Chikiti, said SP (Berhampur) Sarthak Sarangi. On Saturday. Lakshman Behera had died during treatment. Two other deceased persons were Juru Behera and Loknath Behera, At least 15 people from Jenapur and Karabalua area were admitted to the medical college and hospital August 19, after they consumed the suspected spurious liquor from a vendor, who allegedly sold the country-made liquor at Maundapur village.

Imphal: Two persons, including a woman, were killed and nine others injured when suspected militants launched a gun-and-bomb attack in Manipur's Imphal West district Sunday, police said. According to police, militants fired indiscriminately from hilltop positions towards the low-lying valley areas of Koutruk and neighbouring Kadangband killing two persons and injuring nine others. Several houses were also damaged due to heavy shelling by the militants, they added. The sudden assault on the unsuspecting village caused widespread panic, forcing many residents, including women. children, and the elderly, to flee to

6 hostages killed in Gaza

Jerusalem, Sept 1: Israel recovered the bodies of six hostages from a tunnel in Gaza where it said they were killed shortly before its troops reached them, triggering protests by Israelis Sunday and planned labour strikes over the failure to save them.

Thousands of Israelis demonstrated in Jerusalem and Tel Aviv, demanding that Prime Minister Benjamin Netanyahu do more to bring the remaining hostages home from Gaza. Labour leaders urged workers to down tools Monday. The Israeli military announced

the recovery of the bodies from underground in the southern Gaza city of Rafah, as a polio vaccination campaign began in the war-shattered Palestinian territory and violence flared in the occupied West Bank.

The bodies of Carmel Gat, Hersh Goldberg-Polin, Eden Yerushalmi, Alexander Lobanov, Almog Sarusi and Ori Danino have been returned to Israel, military spokesperson Rear Admiral Daniel Hagari told reporters.

Helsinki, Sept 1: A white beluga whale named 'Hvaldimir', first spotted in Norway not far from Russian waters with a harness that ignited rumours he may be a Moscow spy, has been

The Norwegian public broadcaster NRK reported that the whale carcass was found floating at the Risavika Bay in southern Norway Saturday by a father



and son who were fishing.

The beluga, named by combining the Norwegian word for whale — hval — and Russian President Putin's first name Vladimir, was lifted out of the water with a crane and taken to a nearby harbour where experts will examine it.

"Unfortunately, we found

Hvaldimir floating in the sea.

He has passed away but it's not immediately clear what the cause of death is," marine biologist Sebastian Strand told NRK, adding that no major external injuries were visible on the animal.

Strand, who has monitored Hvaldimir's adventures for the past three years on behalf of **Experts said the Russian** navy is known to have trained whales for military purposes

the Norway-based Marine Mind non-profit organisation, said he was deeply affected by the whale's sudden death. "It's absolutely horrible," Strand said. "He was apparently in good condition as of (Friday). So we just have to figure out what might have happened here.

The 4.2-metre long and 1,225kilogram whale was first spotted by fishermen near the northern island of Ingøya, not far from the Arctic city of Hammerfest, in April 2019 wearing a harness and what appeared to be a mount for a small camera and a buckle marked with text "Equipment St.

Petersburg".

That sparked allegations that the beluga was "a spy whale". Experts said the Russian navy is known to have trained whales for

military purposes Over the years, the beluga was seen in several Norwegian coastal towns and it quickly became clear that he was very tame and enjoyed playing with people, NRK said. NGO Marine Mind said on its site that Hvaldimir was very interested in people

and responded to hand signals. 'Based on these observations. it appeared as if Hvaldimir arrived in Norway by crossing over from Russian waters, where it is presumed he was held in captivity," it said.

Norwegian media have speculated whether Hvaldimir could have been used as "a therapy whale" of some sort in Russia.





Storm over Pradhan's 'Ravenshaw' suggestion

Bhubaneswar, Sept 1: A political storm erupted in the state following Union Minister Dharmendra Pradhan's remarks suggesting renaming of Ravenshaw University, one of the oldest educational institutions in Odisha at Cuttack, with the Opposition BJP and BJD -as well as students' bodies- objecting to the senior BJP leader's proposal.

The university, established around 156 years ago in 1868, was named after Thomas Edward Ravenshaw, the then commissioner of the Odisha division.

"The people of Odisha as well as intellectuals should ponder over the fact whether we need an institute named after Ravenshaw Saheb during whose tenure the 'Na Anka Durbhikshva' (devastating famine of 1866) occurred in Odisha. What did the administrative officials do during the famine in Odisha? Is the person who was helpful in tormenting Odia people a matter of pride for us?" Pradhan said Saturday.

He, however, said it was his per sonal opinion and a debate should be held over the issue.

Launching a scathing attack on the Union Minister over the issue, BJD leader Lenin Mohanty said Ravenshaw University is a pride for each and every Odia.

He said that Pradhan should have read a little bit of history before linking 'Na Anka Durbhikhsya' (1866 famine) to

Notably, Ravenshaw University boasts a rich academic legacy with illustrious alums including former chief ministers Harekrushna Mahatab, Nandini Satpathy, Biju Patnaik, noted historian Ramesh Chandra Majumdar, former chief justice of Supreme Court of India, Ranganath Mishra, etc.

The university was established in 1868 as a collegiate school and later converted to a full-fledged degree college in 1876 due to the efforts of Thomas Edward Ravenshaw, the then commissioner of the Odisha division.

During Ravenshaw's tenure as the commissioner, the state witnessed a devastating famine in 1866, locally known as 'Na Anka Durbhikhsya'. More than one-third of Odisha's population was wiped out due to the dreadful famine of 1865-66.

Bhubaneswar, Sept 1: Heavy rain lashed parts of Odisha Sunday under the impact of a depression that lay centered over the southern part of the state and north Andhra Pradesh, officials said.

Several districts of south Odisha, including Koraput, Malkangiri, Nabarangpur, Gajapati and Rayagada received heavy rainfall, they said

The system moved with a speed of 15 kmph during the past six hours and lay centered over south Odisha and adjoining north Andhra Pradesh, the IMD said in a bulletin.



It is likely to move west-northwestwards across south Odisha and south Chhattisgarh and weaken into a well-marked, lowpressure area during the next 24 hours, the weather office said. The IMD forecast fairly widespread light to moderate rainfall in the state during the week. Isolated heavy rainfall might continue in the state till September 4, it said.

Fake cop who tricked City woman into marriage held

Bhubaneswar, Sept 1: The Khandagiri Police Sunday arrested a man who allegedly tricked a woman into marriage and fleeced her by impersonating as a police inspector. Investigations have revealed

that Subhash Chandra Pradha, 55, who is a native of Bhadrak district, had duped three more women in the past using the same modus operandi, ACP Zone- III Tapas Chandra Pradhan said. In the present case, Pradhan

said, Subash introduced himself as 'Manoj Mishra' to the victim, claiming that he is an inspector working at Sector-17 police station in Rourkela. Subash had also faked his identity in his social media handles, which showed him as a cop (in uniform) in several pictures.

The ACP said the accused tricked the woman into a relationship after sending her 'friend request' on her Facebook account. As they became close, Subash proposed her for marriage. "Prior to the wedding, Subash had shown fake pictures of him that included him addressing subordinate cops in uniform, and doing night patrolling duty as a cop," the victim mentioned in her complaint, adding that their relationship continued for four-years.

"Following the wedding August 21, 2023, his behavior became suspicious as he refused



to take me to his home. He said that my name needed to be updated in his 'Service Records Book', so that he could introduce me to his family and colleagues. In addition, he cited that his sister-in-law is vehemently opposing his marriage, therefore, he needed few days to calm her anger," the victim said in her complaint.

"The truth was laid bare after the victim, out of suspicion, checked the number plate of Subash's four-wheeler. She then found that his actual name was 'Subash', and not 'Manoj'," said

Preliminary investigations have revealed that Subash had swindled the victim of several thousand of rupees under various pretexts.

The Khandagiri Police booked Subash under Sections 419, 420, 493, 323 and 313 of IPC, and produced him before a local court



"As we work towards a more just and equitable society, let us commit to upholding the rights of all children, especially those with disabilities," he added.

Participants at the event were urged to focus on the steps taken by the state to protect children with disabilities across legal categories defined by the Juvenile Justice Acts such as Children in Need of Care and Protection (CNCP) and Children in Conflict with the Law (CCL).

"It is not individuals with disabilities who are necessarily deficient. Our current system has also some deficiencies in providing equal treatment and opportunities to the disabled. The purpose of today's consultation is to find out these loopholes and fill the gaps, so that we have a better future," said Justice Debabrata Dash, chairperson of the Juvenile Justice Committee.

A Unicef study of August 2022 on Children with Disabilities estimated that one in three children in institutions have a disability. Additionally, children with disabilities are disproportionately represented in childcare institutions, with some estimates suggesting that up to 25 per cent of all young people in such facilities have intellectual disabilities or mental health con-

According to the study, the mortality rate for children with disabilities in institutional care is 100 times higher than compared to other children.

"The cost of excluding children with disabilities would defeat our global commitment to 'Leaving No One Behind.' We must reaffirm our commitment to creating an enabling ecosystem where children with disabilities are included, protected, and empowered to reach their full potential," said William Hanlon Jr, Chief of Field Office, Unicef.

Speaking on the occasion, Bishnupada Sethi, Principal Secretary, Social Security and Department of Empowerment of Persons with Disabilities (SSEPD) said, "The focus is now on the needs, issues and contributions of about 60 to 70 lakh people with disabilities in Odisha. If we want our state to become a developed state and aim to achieve a \$500 million economy by 2036, and a \$1.5 trillion economy by 2047, then we have to reaffirm our commitment towards people with disabilities.

Mosquito-mating cues could lead to improved malaria control

THE FINDINGS COULD **HELP IMPROVE THE EFFECTIVENESS OF MOSQUITO TRAPS, NOT ONLY FOR MONITORING SPECIFIC MOSOUITO SPECIES BUT ALSO FOR POPULATION CONTROL**

n international team led by researchers at the University of Washington has uncovered surprising details about mosquito mating, which could lead to improved malaria control techniques and even help develop precision drone flight. In a paper published in the journal Current Biology, the team revealed that when a male Anopheles coluzzii mosquito hears the sound of female-specific wingbeats, his vision be-

Many mosquito species have relatively poor vision, and Anopheles coluzzii - a major spreader of malaria in Africa is no exception. But the team found that when a male hears the telltale buzz of female flight, his eves 'activate' and he visually scans the immediate vicinity for a potential mate.

Even in a busy, crowded swarm of amorous mosquitoes, which is how A. coluzzii mates, the researchers found that the male can visually lock on to his target. He then speeds up and zooms deftly through the swarm and

avoids colliding with others. Saumya Gupta of the University of Washington, Seattle, said it was previously thought mosquitoes had such poor vision they could not see each other. What is more, male mosquitoes are known to tune out the sound of other males – meaning they could not rely on their acute hearing to avoid collisions.

Now Gupta and colleagues



have shed fresh light on how the

insects manage the feat "We have discovered this incredibly strong association in male mosquitoes when they are seeking out a mate. They hear the sound of wingbeats at a specific frequency - the kind that females make - and that stimulus engages the visual system," said Gupta. "Not only have we found mosquitoes can see visual cues of other individuals flying around," said Gupta, "but we found that for males they actually can integrate acoustic cues with visual cues to find a female."

Writing in the journal Current Biology, Gupta and colleagues report how they tethered anopheles mosquitoes within an arena whose walls were covered with an LED panel showing a static pattern of bright pixels. This, they say, mimics aspects of what a mosquito would see in a swarm.

The team then put a large moving blob of light on the LED display to represent another mosquito very nearby.

The researchers found the tethered mosquitoes showed no inclination to steer towards or away from the large blob, although they did change the frequency and amplitude of their wingbeats.

However, when the highpitched whine of a female was played, males strongly steered in the direction of the blob's movement. "As soon as they hear female sounds, they try to intercept the object," said Gupta. In other words, the sound of a female

mosquito appears to trigger a shift in the visual processing of

The team also looked at freeflying male mosquitoes, finding they did indeed try to avoid collisions when close to each other in a swarm. However, rather than steer-

ing away to dodge collisions, the

insects made other changes in their acceleration - chiming with the results of the earlier experiments. Francesco Baldini from the University of Glasgow, who was not involved in the work, said the

results were exciting. "They reveal that mosquitoes respond to visual cues not just based on what they see but also on what they hear. Baldini added that the work could help improve the effec-

tiveness of mosquito traps. not only for monitoring specific mosquito species but also, if highly effective, for popula-

Jajpur, Sept 1: Although the state government has reportedly established krushi seva kendras (KSKs) to rent agricul tural equipment to farmers at a nominal price, lack of awareness among the peasants and apathy of the KSKs have rendered the scheme defunct while the resultant surge in agricultural input costs have denuded the profit margin of farmers.

Official sources said the state government, in a bid to reduce the production cost of the crops, has established 2,795 KSKs during the period from FY 2013-14 to January 2024. KSKs provide tractors, power tillers, paddy harvesters & cutters, seedling planters, seeding machines, disc ploughs, sprinklers, motor pumps and pesticide sprayers to farmers on a fair price basis. Though 10 years have elapsed to the rollout of the scheme, many farmers in rural areas are unaware of it. As a result, farmers in rural areas are shelling out more from their pockets to hire these farm equipment from pri-

As a result, paddy farmers' cost of production has increased and profit reduced. Sources said paddy farmers have reportedly spent around ₹1,455 per quintal but sold it at a meagre ₹2,183 in 2023-24 FY. Moreover, farmers in many areas have reportedly resorted to distress sale. ing new. Farmers are being demanded bribe anything between ₹8,000 to ₹10,000 for sanction of a loan or enlistment of their names in agricultural schemes.

The state government has ruled that secretary or managing director of a primary agricultural credit society (PACS) or the large area multipurpose society (LAMPS) can neither withheld nor use the loan passbook or cheque book of farmers. However, this order is yet to be executed in letter and spirit as the officials of these societies continue to dictate terms over the farmers.

Farmers have failed to bring any change in their financial condition as the cost of production has been rising.

Farmers Damodar Das, Sudam Charan Sahu, Jogendra Sahu, Anurodh Swain and Jyotiranjan Mohanty said that they do not have any knowledge as to what a KSK does. They admitted that they came to know from this correspondent about renting of farm equipment at subsidised prices by the KSKs.

Currently, they are hiring a tractor at ₹1,200 per hour and a paddy cutter at ₹2,200 per hour from private vendors.

When contacted, assistant registrar of cooperative societies, Jajpur, Benudhar Mallick said KSKs are yet to become functional in Jajpur district while the state government claims to have established 22 KSKs in the district. Locals and farmers have alleged that this is nothing but eyewash and the state government is just hoodwinking the people.

Man held for rape, murder of minor girl

Balasore, Sept 1: A 46-yearold man has been arrested on charges of raping and murdering a nine-year-old tribal girl in Balasore, police said

According to Remuna police in-charge Hasina Kulu, the girl went missing from her home August 27, and her decomposed body was discovered in an abandoned house

August 30. Accused Rabi Singh was arrested Saturday and has been charged under various Sections related to rape and murder, including sections 103, 165, 4(2) of the BNS Act, and POCSO Act, Kulu said, adding that he has been remanded to judicial custody

for 14 days. "Investigation revealed that the accused is a friend of victim's father and slept at their home before the day of the crime. The next morning, the accused took the girl for snacks and brought her to an abandoned house where he committed the crime. He later used a piece of concrete slab to smash her head," the officer said.

BJD president and Leader of Opposition Naveen Patnaik raised the issue in the Assembly Saturday, criticising the current government's

handling of crimes. "All major crimes, including this latest case, should be informed to the Chief Minister, who is also the Home Minister. This is a serious matter which never occurred during my government's tenure," Patnaik said.

2-year-old dies as wall caves in; parents critical



Bhanjanagar, Sept 1: A two-yearold boy was killed while his parents sustained severe injuries after a rain soaked wall of their house collapsed on them while they were asleep at Baibali Totasahi village under this tehsil of Ganjam district Saturday night.

The deceased was identified as Rushi Pradhan, son of Basant Pradhan. Basant and his wife have been admitted to Bhanjanagar hospital. Bhanjanagar police, revenue and forest personnel rushed to the village and launched a probe into the incident.

The incident occurred two months after an elephant herd strayed into the village and partially pulled down the wall of their house. Basant had applied for assistance informing both the Forest and Revenue departments, but to no avail.

The officials of both the departments only conducted a probe and left the village without provillager.

Basant also failed to repair his house due to his abject poverty. However, as ill fate could have it, the damaged wall which had got soaked in rain, collapsed on the family members when they were asleep Saturday night.

Hearing their screams, neighbours rushed to the spot and rescued the trio before admitting them to Bhanjanagar hospital. The boy succumbed to his injuries during treatment Sunday morning. His parents are still undergoing

Bhanjanagar MLA Pradyumna Kumar Nayak expressed his grief over the child's death and directed the hospital authorities to provide proper treatment to the injured parents. Students, Jobs, Suicides

disconcerting new report has revealed that student suicides in India have now surpassed the country's population growth rate. The report titled "Student suicides: An epidemic sweeping India" has been compiled by the IC3 Institute, a volunteer-based organisation that provides support to high schools around the world, based on data from the National Crime Records Bureau (NCRB).

Over the last decade, while the population of the 0-24 age group has reduced from 582 million to 581 million, the number of student suicides has increased from 6,654 to 13,044, the report pointed out. Notwithstanding a likely under-reporting of student suicides, such cases have grown by four per cent annually as against a two per cent increase in the overall suicide numbers.

While Maharashtra, Tamil Nadu, and Madhya Pradesh account for the highest number of student suicides in that order, Rajasthan, home to the infamous Kota coaching hub, comes at the tenth position. Kota saw 15 student suicides in 2022, while the number increased to 27 in 2023, as reported by Rajasthan police. It is pertinent to note here that the actual numbers could be higher as not all suicides are reported to the police, especially due to the social stigma associated with it. Even if reported, the causes of death are altered so that the figures may not add

This alarming trend has been noticed over the last decade when both parental and societal pressure, coupled with a sagging economy, has taken a toll on the younger population. Academic pressure has always been higher in this country with seats in reputed educational institutions being scarce compared to the huge number of aspirants. This has been true even in the case of jobs as we frequently come across news reports of thousands applying for a handful of positions. The economy, in spite of all the loud talk about the country having the fastest growing GDP, has simply not been able to absorb the hordes of job seekers. This is also a major reason for the terrible antipathy faced by those who benefit from 'Reservation' which is, till now, limited to government jobs only. Admittedly jobs offered by all governments at state and Union level are considered plum picks by only those who are not brilliant in any field and wish to enjoy the fruits of everything at the cost of the tax payer.

This problem is better understood when it is accepted that the idea is ingrained in the average Indian psyche that the search for a "dream job" often ends up in three professions, namely medical, engineering and civil services. The last one being the most sought after. It is interesting to note here that most of the students die by suicide while pursuing studies for these professions. Parents rarely support their wards to take up any other profession, while entrepreneurship is often looked at with disdain as none wants to take the risks associated with such an endeavour. Ironically, it is the entrepreneurs, especially the small and medium sized ones, who employ the bulk of the workforce in this country and contribute the most to the economy.

To tide over this situation, an environment should be created wherein the youth see hope rather than gloom in their future. This should begin right from home where parents need to stop having unusually high expectations from their children. Secondly, our institutions of education should shift their focus from being factories for only producing job-ready individuals. They should rather become platforms inculcating necessary skills in students -- skills that would make them independent in their lives, not just land them a job. Unfortunately, the concept of 'Campus recruitment' has long been the yard stick to discover excellence in educational institutions. By offering education that makes students self dependent, these institutions could help the country to reap the demographic dividend accruing from a growing young population. Otherwise, this same growing population could lead to a demographic disaster instead.





SENSEX SURGE AN ILLUSION

IF THE BUBBLE **BURSTS, IT COULD BECOME A MAJOR CRISIS** HITTING **INDIVIDUALS AND THE ECONOMY**

ensex closing above 82,000 may grab headlines, but it doesn't reflect the true market buoyancy. SEBI has raised alarms over unscrupulous practices in the SME and real estate investment trusts (REITs), underlining the need for tighter regulations. While Sensex touched 82,135 and Nifty peaked at 25,152, this surge tells only part of the story. Despite these highs, most individual stocks remain stagnant, with demand concentrated only in select large cap stocks. The recent rallies are largely driven by IT and FMCG sectors, influenced by cues from the US market, rather than a broad-based market recovery.

Mid and small cap stocks have been witnessing selling pressure. The REITs have many problems, including compliance of regulations, SEBI chairman Madhavi Puri Buch told Global Fintech Fest in Mumbai. She hinted at considering the possibility of changing the complexion of indices for benefiting investors in their long-term interest. It is a revealing statement on the health of the market and warning to investors. Buch says that compliances should be like natural breathing. The SEBI would not tolerate any innovation for shortchanging investor interest. "That is opacity and lack of concern for investor money.'

The SEBI earlier specified that SMEs after listing their companies, resort to illegal means to paint a rosy picture about their businesses, pump up stock prices and exit. This way they have amassed ₹14,000 crore over a decade since SME stocks were launched in 2012. Of this, ₹6,000 crore were raised in 2024 alone. These firms project unrealistic pictures. The announcements are followed up with various actions like bonus issues, stock splits and preferential allotment to create a positive sentiment to induce buyers to purchase at el-

evated prices.

The SEBI mentioned about some companies listed at NSE's SME platform in 2022 wherein after listing, promoters resorted to rampant related transactions to show a sharp jump in business and revenues. Then it migrated to the main board, launched a preferential allotment to entities related to the promoters. Soon after the shares from this allotment were transferred to the promoters and sold in the market. The promoters made ₹89.2 crore illegal gains while shareholders were left with worthless shares.

While financial sector risks in larger and higher per capita income countries are moderate. half of lower-income countries face significant risks, World Bank Financial and Prosperity Report 2024 denotes. Nearly 70% of countries facing high financial sector risks are currently not adequately prepared to handle financial stress. The report also identifies a particular risk facing financial sectors in several countries: a large and growing exposure to sovereign debt. This exposure surged to its highest level in the past decade. It signifies that the regulators have tougher

job to do than mere facilitating companies dishing out a glorious picture ignoring the risks for increasing profits.

Buch says that a consultation paper proposing changes to the rules for trading index-based derivatives received 6,000 comments. This is an indicator of investors' concern. The SEBI would use technology to scan the comments and may revise the index compositions and regulatory mechanism.

The Sensex is India's oldest index. It is an economy-weighted, free-float index with 30 financially sound, well-established companies listed on the BSE. These 30 firms, among the most successful and highest traded. represent various industries in India. The Indian stock market has been dominated for decades by narrow large cap benchmarks. One of them is the S&P BSE Sensex. The competing indices are similar in size and representation. These indices capture 40-60 per cent of the Indian market capitalisation. Critics say that Indian market participants have a narrow range of choices to make a true selection for benchmarks. It should capture 80-90 percent of the market capitalisation to reflect the actual market movements. The S&P 500 is also designed for exposure of large cap stocks and represents about 70% of the US equity market. However, liquidity in the Indian stock market sits in the top 100 stocks and tapers off sharply at just the halfway point.

The foreign portfolio investors (FPIs) are the major players in Indian equity market. Foreign investors have been net sellers since the Union Budget 2024. The FPIs have withdrawn ₹16,305 crore from Indian equities in August, driven by a mix of global economic concerns, including the unwinding of the yen carry trade, recession fears in the US and ongoing geopolitical conflicts in the Middle East. This pullout from equities highlights the cautious stance of overseas investors who are rebalancing their portfolios in favour of more stable and secure investment avenues.

The FPI preferences are making a shift to debt market amid global turbulence. According to data from the National Securities Depository Limited (NSDL), FPIs have poured in ₹1,02,354 crore into the Indian debt market so far in 2024. Stock operators say that that the FPI strategy is to sell India which is expensive and buy China which is inexpensive mainly through Hong Kong. The price to earnings or PE ratio in India is more than double the PE ratio in Hong Kong. This incongruity of the Indian scrip leads to 'Sell India, Buy China' trade by foreign investors.

The booming stock market may be a bubble. The middle class transferred their savings to mutual funds and stock market creating problems for banks. The Reserve Bank of India has flagged this. Many also borrowed heavilv. If the bubble bursts, it could become a major crisis hitting individuals and the economy.

Rethinking emissions targets

tionally determined contributions (NDCs) in the 2015 Paris climate agreement to limit global warming, countries have struggled to meet their emissions-reduction targets. This is particularly true for developing countries, where pressing economic and political challenges tend to overshadow long-term climate objectives.

Implementing effective climate policy requires a shift in thinking. Climate change is both a negative externality and an inequality problem, raising the question of who should bear the costs of climate action within and between countries. Policymakers should focus more on the complicated tradeoff between economic efficiency and equity to ensure that developing countries do not shoulder the burden of the rich world's historical carbon dioxide emissions. and that measures are in place

to safeguard future generations. Of course, the Paris agreement set clear goals while adhering to the principle of "common but differentiated responsibilities," which means that all countries are responsible for addressing climate change, but not equally so. But there is still a tendency to focus on uniform targets. Consider the global push for net-zero greenhouse-gas (GHG) emissions by 2050 – a complimentary long-

espite committing to na- term goal outlined in the Paris agreement, and one with respect to which many developing countries remain far off track

> To achieve this ambitious goal, countries must be able to devise climate policy based on their capabilities and historical responsibilities, rather than adopting a one-size-fits-all strategy. Recent research suggests that this would require net-negative emissions targets for high-income countries, while allowing low-income countries to generate net-positive emissions. Of course, such differentiation is not a free pass: developing countries would still have to reduce GHG emissions. But this approach, embodying the spirit of 'common but differentiated responsibilities," better reflects their economic conditions and development needs.

Moreover, financial assistance from developed to developing countries to support climate action has been ineffective, owing mainly to transparency and accountability problems. In this context, the same study finds that carbon sequestration and capture, whether through technological innovations or natural solutions, could be a politically feasible alternative to direct monetary transfers. Enabling each country to monitor its own efforts to absorb carbon could bring the world closer to netzero emissions while respecting diverse national circumstances.

Emissions in Latin America, for example, are split almost equally between energy, agriculture and livestock, and land use, whereas they are largely energy-related in the United States and Europe. Promoting sustainable agricultural and livestock practices – as opposed to focusing solely on decarbonizing the energy system could therefore help reduce emissions in the region, as well-managed pastures and soil can increase carbon sequestration. This approach would also align private incentives with social returns by revaluing land and allowing farmers to remain internationally competitive.

The case of Argentina illustrates how improving the sustainability of agriculture and livestock could play a pivotal role in the transition to a green global economy. A series of economic crises, coupled with increasing political volatility, have led the Argentinian government to focus more on immediate problems than climate policy. But given the country's position as a leading food producer, revamping these industries could help it enhance climate mitigation and adaptation – and contribute meaningfully to international goals – while recognising its economic conditions and development needs. Addressing domestic in-

equality is equally crucial in shaping effective climate policies in Argentina and other developing countries. Ongoing research demonstrates that conventional approaches, including uniform carbon taxes, fail to account for nuanced socioeconomic disparities. Implementing progressive taxation based on income levels or consumption patterns, such as higher taxes for frequent flyers, may yield better outcomes. Regardless, this problem demands innovative policy solutions that mirror the complexity of global climate governance.

Framing climate change as an inequality problem does not require compromising on global goals; rather, it underscores the importance of differentiated targets. Many developing countries remain a long way away from a fully decarbonized energy system. While taking steps toward that end, these countries should be encouraged to implement climate policies that harness innovations and alternative strategies for reducing emissions.

Erratic weather has led to stunted crop growth and increased reliance on costly groundwater irrigation

Lucknow, Sept 1: The monsoon season in Uttar Pradesh officially ends this month but the uneven distribution of rainfall it brought has made the state's farmers apprehensive about the yield of Kharif crops this time.

Over half of its districts have received below-normal rainfall since June. Of the 75 districts of Uttar Pradesh, 37 have received deficient rainfall so far and seven witnessed excess, while 31 districts mostly in the central and eastern parts received normal rains, according to India Meteorological Department (IMD) data.

The state's Rohilkhand, and central regions have been particularly impacted by this erratic monsoon pattern.

Shamli, in western Uttar Pradesh, is the hardest hit, recording only 20.2 per cent of its normal rainfall. Farmers in the district are struggling with stunted crop growth due to insufficient rains, according to marginal paddy farmer Muqeem Khan.

"We cannot grow paddy without sufficient rain. I have paddy sown in over two acres of land but the growth of the crop is not good because of less rainfall,'

Known for its superior paddy crops, Shamli has received just 90.8 mm of rainfall of the normal 448.4 mm so far this year. According to the IMD calendar, the southwest monsoon season begins June 1 and ends September 30.

Not just less rainfall but even rainfall on fewer days also affects Kharif farmers. These changes particularly harm waterintensive crops like paddy.

Gautam Buddh Nagar, Amroha, Fatehpur and Jaunpur have also faced significant

"I planted paddy in the first week of July. Due to the lack of rain, we were forced to use tube wells. But there has been no rainfall and I cannot afford to pay to cultivate my farm using groundwater only," laments paddy farmer Nakul Pal in Amroha.

Pal (65), who takes farmland on lease for cultivation, said, "I have been cultivating paddy since I was a teenager, but the monsoon season has become erratic over the last few years.

IMD data shows Gautam Buddh Nagar district has received just 20.9 per cent of its normal rainfall so far, followed by Amroha at 40.6 per cent, Kushinagar at 41.3 per cent, Chandauli at 43.1 per cent, Fatehpur at 43.6 per cent, Saharanpur at 43.7 per cent, Jaunpur at 46 per cent and Amethi at 48.4 per cent.

Climate scientists attribute this imbalance to a weaker southeastern monsoon, influenced by western disturbances.

Sumit Singh Vyas, a climate scientist and former adviser to the Union agriculture ministry, said a belt of low-pressure zone caused partially by western disturbances has affected the progression of the normal monsoon. "This leads to unequal and sudden changes in the monsoon pattern," he added

Vyas said these changes cause both delays in monsoon and a decrease in the frequency of the monsoon. "This leads to the delaved start of the monsoon season and rainfall on fewer days during the season," he explained.

As per IMD data of the last 12 weeks of the monsoon season. western Uttar Pradesh saw only two weeks of normal rainfall.

Even in the districts that saw relatively normal rainfall, the irregular patterns of downpours have made it difficult for farmers to plan their agricultural ac-

Concerns over Kharif HEAVY RAINS LASH PARTS OF T'GANA

Hyderabad, Sept 1: Nine persons died in separate rain-related incidents in Telangana as heavy downpour continued to lash many parts of the state including Hyderabad Sunday.

Chief Minister A Revanth Reddy held an emergency review in view of the incessant rains in the state and spoke to ministers over phone and relief measures in submerged areas, an official release CM HOLDS

next 24 hours. He directed district Collectors, SPs. Revenue, Irrigation and Municipal officials to conduct field visits in flood-hit habitations. The authorities have been instructed to take immediate relief measures in flood-hit areas.

Following heavy rains, rivulets were in spate and low-lying areas were inundated at several places in the state and flood water disrupted road links between villages. Trees were uprooted under the impact of the heavy rain and winds, while branches of trees have fallen on roads.

Revenue Minister Ponguleti Srinivas Reddy said precautionary measures taken in time resulted in saving of lives and property.

Despite the measures, nine persons lost their lives in various parts of the state in separate rain-related incidents, he said.

Three persons were also feared washed away in Mahabubabad and Khammam districts.

In other districts like Suryapet,

Bhadradri Kothagudem, Mahbubabad and Khammam authorities evacuated residents of several flood-hit villages to safety, the Minister said.

He said some people have been shifted to relief camps in Greater Hyderabad Municipal Corporation limits as a precautionary measure as there is a possibility of rain-soaked old houses collapsing.

He said the District Collectors have been asked to declare a holiday for educational institutions as per local conditions September 2. Due to the forecast of heavy rains in Hyderabad district, a holiday has been declared for all Primary and Secondary Schools, under all managements (Government, Aided, and Private) September 2, as a precautionary measure to ensure the safety of the children, officials said.

The SCR official said due to incessant rains in Andhra Pradesh and Telangana over the past 24 hours there has been flooding and breaches in Kazipet to Vijayawada section and five trains in that section were stranded even as officials moved 15 trains via a diverted path.

Due to heavy rains, water is flowing on NH 65 at Chillakallu and Nandigama in Andhra Pradesh and the Paleru river is overflowing on the road at Nayakinigudem on the way from Suryapet to Khammam in Telangana, police said.

Therefore, vehicles have been stopped on this route and those going to Viiavawada via Survapet and those going to Khammam should put off their journey, Suryapet District Superintendent of Police Sunpreet Singh said in a release.



Amaravati, Sept 1: Andhra Pradesh's Education Minister Nara Lokesh Sunday denied that there were any hidden cameras at Gudlavalleru Engineering College in Krishna district and dismissed the recent controversy as a dispute among four students.

He told media persons that there were no hidden cameras anywhere in the college and alleged that the issue was sensationalised by a section of the media.

The minister clarified that no videos or evidence have emerged to support the allegations of hidden cameras. "There was no hidden camera anywhere. Not a single video has surfaced," he said and remarked that the 'blue media' tried to sensationalise it. He was referring to media outlets considered close to the opposition YSR Congress Party.

Lokesh alleged that this media was working only to sensationalise any small issue happening anywhere. "Ever since I became Education Minister, there has been a focus on me. I am ready for that focus. I have no problem," he said.

Stating that the media "knows" what happened at the college, Lokesh said those involved were arrested. "It was a dispute among three to four students. We arrested them. Who spoke to whom and where, it was all being reviewed from the office of the Director General, Intelligence but there was no hidden camera anywhere," he said.

Replying to a query from a reporter, Lokesh asked him to show the hidden camera. He said police searched the campus and students could not show any hidden cameras.

The alleged fixing of a hidden camera in the girls' washroom in the college hostel sparked huge protests by students August 29 and 30. Protesters had alleged that cameras were installed in the women's toilet a few days ago and that the warden and the college management failed to take any action despite complaints. Police seized the laptops, mobile_ phones and other electronic gadg-

MHA forms team to assess damage

New Delhi, Sept 1: The Ministry of Home Affairs has constituted an inter-ministerial team to assess the damage caused by rainfall and floods in Gujarat.

The team will shortly visit the flood-affected districts of Guiarat, which was hit by heavy to extremely heavy rainfall between August 25 and 30 caused by a deep depression formed over Rajasthan and Gujarat, according to an official statement.

At least 25 people have died in rain-related incidents across the state August 26 and 27. The statement said the MHA has constituted an inter-ministerial central team (IMCT) led by the executive director, the National Institute of Disaster Management (NIDM), to assess the damage caused by rainfall and floods in Gujarat, the statement said.

Madhya Pradesh and Rajasthan were also affected by heavy to very heavy rainfall. Multiple spells of heavy rains, cloudbursts and landslides have caused extensive damage in Himachal Pradesh this year. The MHA is in touch with senior of-

2 dead, 9 hurt in firing by militants in Manipur

Imphal, Sept 1: Two persons, including a woman, were killed and nine others injured when suspected militants launched a gun-and-bomb attack in Manipur's Imphal West district Sunday, police said.

According to police, militants fired indiscriminately from hilltop positions towards the low-lying valley areas of Koutruk and neighbouring Kadangband killing two persons and injuring nine others.

Several houses were also damaged due to heavy shelling by the militants, they added.

Of the nine injured, five sustained bullet wounds, while the others suffered splinter injuries from bomb explosions, hospital officials said. The sudden assault on the unsuspecting village caused widespread panic, forcing many residents, including women, children, and the elderly, to flee to safer areas, police added.

The body of the deceased woman, identified as 31-year-old Ngangbam Surbala Devi, has been taken to the Regional Institute of Medical Sciences (RIMS) for post-mortem examination. The identity of the other victim is yet to be ascertained, police said. Security forces, including state and central units, have been deployed in the area to stabilise the situation.

Soil health crucial for crop yields: Experts

A meeting-cum-interactive session was held here Saturday to deliberate on 'soil biological health and cultivation of quality food as per international standards'.

Pakistan confirms fourth mpox case

Islamabad, Sept 1: Authorities in Pakistan Sunday reported another case of monkeypox (mpox) virus amid the confusion about the total number of cases confirmed so far in the country. The fourth case was detected

in Khyber-Pakhtunkhwa province where authorities confirmed three previous infections of the virus "The medical team at

Peshawar airport transferred the patient (fourth case) to the Police and Services Hospital (PSH) after detecting symptoms of the virus during the screening," KP Health Director Dr Irshad Ali Roghani said.

Roghani said the rapid response team took samples from the patient's wound in the hospital and sent it to the laboratory which confirmed mpox in the patient, who was reported in a stable condition. According to officials, all pa-

tients returned from abroad and so far there was no local case reported.

from Khyber Apart Pakhtunkhwa, health officials August 19 reported that a 47-

year-old resident of Pakistan occupied Kashmir, who recently returned from Saudi Arabia, was admitted in the Pakistan Institute of Medical Sciences (PIMS) here due to mpox symptoms.

Dr Nasim Akhtar, the hospital's focal person, had told the media that the patient showed symptoms consistent with mpox and was placed in a special ward designated for such cases

However, it was not clarified if his mpox infection was confirmed.

Another patient, who was isolated in Karachi Saturday due to symptoms of the virus, was later cleared as no infection of mpox was detected.

There is still confusion over the total number of confirmed cases in Pakistan but the latest confirmation by the Khyber Pakhtunkhwa official suggested there were four confirmed cases in the country.

Pakistan has taken precautions to tackle the disease by putting in place a strict screening system at its airports after it emerged that all the patients confirmed with the virus had returned from abroad

Indian mission announces measures for citizens

Dubai, Sept 1: The Consulate General of India here has rolled out several measures to help Indians avail the benefits of the twomonth amnesty scheme beginning Sunday in the UAE that will allow foreigners residing illegally in the country to either regularise their residency status or leave without incurring penalties.

The amnesty programme applies to numerous visa categories, including expired residencies and tourist visas, as well as for those without documents. However, those who illegally entered the country will be excluded from the programme.

Those adjusting their status can waive fines and fees, with an option to leave without a travel ban.

Under the programme, applicants who desire to return to India may apply for an Emergency Certificate (EC) and those who desire to regularise their residency status may apply for a short-validity passport.

"Applicants can request for EC at the Consulate on a gratis basis (free of charge). Facilitation counters will be set up at the Consulate General of India. Dubai and AwirImmigration Centre, Dubai. The facilitation counter in the Consulate will

be functional from September 2." the Indian Consulate in Dubai said in a statement Saturday.

Applicants can collect the ECs from the Consulate General of India, Dubai on the next day after their submission of the application, it said, adding that applicants can approach any of the BLS centres in Dubai and Northern Emirates as walk-ins to apply for short-validity passports. No prior appointment is required.

BLS centres in Dubai and the Northern Emirates will remain operational on all Sundays from 0900-1700 hours during the amnesty period to service the requirement of applicants who wish to avail the benefit of the Amnesty scheme," the consulate statement said.

Tragic tale of Gaza's orphaned children

Khan Yunis, Sept 1: In the rubble of a Gaza home partially destroyed by Israeli shelling, the cry of a baby rings out. One-year-old Farah knows the word "mummy" but to no avail, her tears won't be soothed by her parents.

She is one of an estimated 19,000 children who have been separated from their parents or are unaccompanied in the Gaza according Unicef figures.

Many parents like Farah's have been killed in the Israeli onslaught on the Gaza Strip, which has killed more than 40,500 people since October. Some are left to fend for themselves, others are taken in by family members young and old.

Farah and her two siblings, Suhail, 9, and Warda, 4, were

the only members of their immediate family left after a bombing on their home in Gaza's northern Beit Lahia. Their parents and two of their siblings were killed in the attack in November

The children's young paternal uncle now looks after them after they were seriously injured in the attack. Since then, the kids have

been struggling a lot, crying and constantly asking about their mother and father," Hashim Masoud, 22, told The National. "It's often hard to console them. especially Farah, who always cries and calls for her mum.' Amid displacement orders

'When he wakes up crying at night, sometimes we just can't calm him down, even though my mother tries to help me. But children sense their mother's presence and calm down with her, it's a well-known fact."





New Delhi: The combined market valuation of eight of the top-10 most valued firms surged ₹1,53,019.32 crore last week, with Bharti Airtel and IT majors Infosys, Tata **Consultancy Services** emerging as the biggest gainers, in line with a record rally in equities. Last week, the BSE benchmark jumped 1,279.56 points or 1.57 per cent. Rallying for the ninth straight session Friday, the 30-share BSE Sensex climbed 231.16 points or 0.28 per cent to settle at an all-time closing high of 82,365.77. During the day, it jumped 502.42 points or 0.61 per cent to hit a record intra-day peak of 82,637.03. The market valuation of Bharti Airtel soared ₹47,194.86 crore to ₹9,04,587.12 crore. Infosys added ₹33,611.37 crore taking its valuation to ₹8,06,880.50 crore.

Car makers report dip in Aug despatches

New Delhi, Sept 1: Leading automakers Maruti Suzuki, Hyundai and Tata Motors reported decline in wholesales in August as the companies curtailed vehicle despatches amid drop in demand and to cut inventories at dealer level.

Market leader Maruti Suzuki India said its total domestic passenger vehicle wholesales were at 1,43,075 units last month as compared to 1,56,114 units in the year-ago month, registering a dip of 8 per cent.

Sales of mini segment cars, comprising Alto and S-Presso, declined to 10.648 units last month as against 12,209 units a year

Despatches of compact cars, including Baleno, Celerio, Dzire, Ignis and Swift, also saw a decline of 20 per cent to 58,051 units as compared to 72,451 units in the year-ago month.

Utility vehicle despatches, consisting of Grand Vitara, Brezza, Ertiga, Invicto, Fronx and XL6, however rose to 62,684 units last month as compared to 58,746 units earlier.

In a virtual press conference, Maruti Suzuki İndia (MSI) Senior Executive Officer (Marketing & Sales) Partho Banerjee said the company reduced vehicle dispatches by 13,000 units in August.

The company's inventory stock level, which was at 38 days in the beginning of August, has now come down to 36 days, he added.

"Our focus has been that our channel partners are able to have a reasonably healthy stock



to sell the vehicles, so we are continuously trying to break the stocks down," Banerjee said.

He noted that the company expects to maintain 36 days of stock at dealers going into the festive season.

Elaborating on the overall industry, Banerjee said SUVs accounted for around 55 per cent of the overall passenger vehicle sales in August.

For Maruti, the share of SUVs has gone up to around 29 per cent as compared to 25 per cent last year, he noted.

Baneriee said the share of strong hybrid models in its portfolio has also risen to 16 per cent from earlier share of 9 per cent.

Besides, the company's CNG penetration in overall sales has risen to 34 per cent, he stated. 'Seeing such a response, we

feel it's an opportunity for us to further enhance our CNG volumes. So we are going to have a very strong marketing campaign with the city gas distributors across the country, wherever they have the gas pipelines. And we are going to start that from this month, in which we are going to have tie-ups with them in terms of marketing strategy,' Baneriee said.

Rival Hyundai reported an 8 per cent dip in domestic dispatches last month at 49,525 units, from 53,830 units in the year-ago period.

Similarly, Tata Motors reported a 3 per cent dip in passenger vehicle wholesales at 44,142 units last month as compared to 45,513 units in the year-ago month.

Kia India said its wholesales increased 17 per cent year-onyear to 22,523 units in August. The automaker had despatched

"With the CPSEs now more strong in terms of balance sheet and having improved on their market capitalisation, it is now time for a relook of the capital restructuring guidelines," an official told PTI.

The amended guidelines are expected to be issued by the finance ministry this month, another official said.

As per the capital restructuring guidelines issued, CPSEs that do not have plans to deploy their capital optimally for business purposes should have a professional look at the surplus funds available to them.

As per the guidelines issued by the Department of Investment and Public Asset Management (DIPAM) in May 2016, every CPSE is required to pay a minimum annual dividend of 30 per cent of PAT or 5 per cent of the net worth. Also, every CPSE having net worth of at least ₹2,000 crore and cash and bank balance of over ₹1,000 crore were required to opt for share buyback. Also, bonus shares are to be issued if the defined reserves and surplus of CPSEs is equal to or more than 10 times of its paid up equity share capital

A CPSE where market price or book value of its share exceeds 50 times of its face value will split-off its shares appropriately.

The intention behind the guidelines is that CPSEs sitting on cash piles are required to pay dividends, which will, in turn, help keep investors interested in the stock. The combined market capitalisation of CPSEs, banks and insurance companies has grown over 500 per cent in the past three years from ₹15 lakh crore to over ₹58 lakh crore.

Also, the government's equity holding has risen four times to ₹38 lakh crore from ₹9.5 lakh crore in January 2021.

So far in 2024-25, ₹10,604.74 crore has been obtained through dividend from the CPSEs.

In the current fiscal year, the government has budgeted to collect ₹56.260 crore as dividend from public sector enterprises, up from ₹50,000 crore in 2023-24 fiscal.

ATF price cut 4.6%, commercial LPG up ₹39 per cylinder

New Delhi, Sept 1: Jet fuel, or ATF, price was Sunday reduced by 4.6 per cent while the rate of commercial LPG used in hotels and restaurants was hiked by ₹39 per 19-kg cylinder in the monthly revision done in line with international oil price trends. Aviation turbine fuel (ATF)

price was cut by ₹4.495.5 per kilolitre, or 4.58 per cent, to ₹93,480.22 per kl in the national capital, according to state-owned fuel retailers. The price reduction will help ease the burden on airlines for whom fuel makes up for almost 40 per cent of the op erating cost.

The reduction follows two rounds of monthly price increases. Jet fuel prices were on August 1 raised by 2 per cent or ₹1,827.34 per kl and by 1.2 per cent (Rs 1,179.37 per kl). These hikes followed a steep 6.5 per cent (Rs 6,673.87 per kl) reduction effected on June 1.

The ATF rate in Mumbai was reduced to ₹87,432.78 per kl on Sunday from ₹91,650.34 previously. Prices differ from state to state depending on the incidence of local taxes.

Alongside, oil firms increased the price of commercial LPG by ₹39 to ₹1,691.50 per 19-kg cylinder.

₹7,320 crore on higher valuations

New Delhi. Sept 1: Foreign investors have adopted a cautious stance and infused ₹7,320 crore in the Indian equities in August owing to high valuation of stocks and the unwinding of the Yen carry trade after Bank of Japan raised interest rates.

This investment was way lower than ₹32,365 crore in July and ₹26.565 crore in June, according to data with the depositories. While September is likely to

see continued interest from FPIs. the flows would be shaped by a combination of domestic political stability, economic indicators, global interest rate movements, market valuations, sectoral preferences, and the attractiveness of the debt market, Vipul Bhowar, Director Listed Investments, Waterfield Advisors, said.

According to the data with the depositories, Foreign Portfolio Investors (FPIs) made a net investment of ₹7,320 crore in Indian equities in August.

The fundamental reason for the poor FPI interest compared to the preceding two months is the high valuation in the Indian market. With Nifty trading at above 20 times estimated FY25 earnings, India is the most ex-



pensive market in the world now. FPIs have opportunities to invest in much cheaper markets and, therefore, their priority is markets other than India, V K Vijayakumar, Chief Investment Strategist, Geojit Financial

Additionally, the unwinding of the Yen carry trade August 24 significantly impacted FPI behaviour, leading to substantial sell off in Indian equities, Bhowar

Services, said.

This unwinding coincided with rising fears of a potential recession in the US and disappointing economic data, which further exacerbated the market's reaction, he added.

Interestingly, FPIs have been selling in the secondary maring their investments towards the primary market, which offers relatively lower valuations. Meanwhile, FPIs infused

Experts believe that inclusion in global bond indices, attractive interest rates, stable economic growth, shift from equities, and favourable long-term outlook have been the key factors driving FPIs to invest in debt.

Investment in debt is led by index inclusion flows. It is since October last year when JP Morgan announced index inclusion, Vishad Turakhia, Managing Director at Equirus Securities, said.

India's inclusion in global bond indices and attractive yields has attracted flows, Nimesh Chandan, CIO, Bajaj Finserv Asset Management Ltd, said.

Also, FPIs are buying in the debt market mainly because the Indian Rupee (INR) has been stable this year and this stability is expected to continue. Geojit's Vijayakumar said.

With this, FPIs investment in equities has reached ₹42,885 crore and ₹1.08 lakh crore in the debt market in 2024 so far.

India's trade surplus with 151 nations; deficit with 75: GTRI

LOW EXPORT AND HIGH IMPORT MAKES CHINA INDIA'S LARGEST TRADE DEFICIT PARTNER

New Delhi, Sept 1: India has recorded trade surplus with as many as 151 countries such as the US and Netherlands, while the country has a trade deficit with 75 nations including China and Russia during the first half of this year, according to think tank GTRI.

The Global Trade Research Initiative (GTRI) said that India does not need to worry about the trade deficit from importing crude oil and coal, however, it must focus on reducing the industrial goods imports, especially from countries like China,

as these threaten India's economic sovereignty.

"Between January and June 2024, India had a trade surplus with 151 countries, representing 55.8 per cent of its exports and 16.5 per cent of its imports, totalling USD 72.1 billion," GTRI

said in a report. The biggest surpluses were with the USA (USD 21 billion) and the Netherlands (USD 11.6 billion)

during January-June this year. 'India had a trade deficit with 75 countries, which accounted for 44.2 per cent of its exports and 83.5 per cent of its imports, resulting in a USD 185.4 billion deficit, much larger than India's overall trade deficit," it said, adding this situation highlights the need to reduce reliance on specific imports and strengthen domestic production.

The data analysis by the think tank also showed that with 23 of 75 countries, India's trade deficit exceeded USD one billion and



these countries accounted for 32.9 per cent of India's exports

and 73.5 per cent of its imports. The top five countries with the highest trade deficits were China with USD 41.88 billion, Russia with USD 31.98 billion, Iraq with USD 15.07 billion, Indonesia with USD 9.89 billion, and the UAE with USD 9.47 billion.

Remaining 18 countries with trade deficit exceeding USD one billion include Saudi Arabia (USD 9.43 billion), Switzerland (USD 8.46 billion), South Korea (USD 6.93 billion), Japan (USD 6.13 billion), Qatar (USD 5.76 billion), Hong Kong (USD 5.21 billion), Taiwan (USD 4.28 billion), Australia (USD 3.34 billion), Thailand (USD 2.60 billion), Germany (USD 2.10 billion), Vietnam (USD 2.07 billion), Malaysia (USD 1.49 billion), Venezuela (USD 1.47 billion), Peru (USD 1.10 billion), and Ireland (USD 1.10 billion).

It added that India should not be concerned about the trade deficit with 11 countries that primarily export crude oil, petroleum products, and coal to

India such as Angola, Iraq, Saudi Arabia, Australia and Nigeria.

But the country "may keep a watchful eye about the trade deficit with 4 out of the 23 countries that primarily export gold, silver, and diamonds to India as tariff cuts in gold and silver in this budget from 15 per cent to 6 per cent may lead to rise in imports," GTRI Founder Ajay Srivastava said.

And these nations include Peru, Switzerland, UAE, Hong Kong. On China, the report said that during January to June 2024, India exported USD 8.5 billion to China while importing USD 50.4 billion, resulting in a trade deficit of USD 41.9 billion.

This low export and high import makes China India's largest

trade deficit partner. "Worse, 98.5 per cent of imports from China, or USD 49.6 billion, are industrial goods. China accounts for 29.8 per cent of India's industrial goods imports. India must invest in deep manufacturing to cut dependence on import of critical industrial products

from China," Srivastava said. Goods whose share of China in India's global imports are more than 50 per cent include umbrellas, artificial flowers, manmade filaments, rolling stock, glassware, leather goods, ceramic products, toys, and musical instruments.

It added that the updated trade data for FY24 now shows the USA as India's top merchandise trade partner, overtaking China.

"The revision added an extra USD 2.8 billion in global imports, bringing India's total imports to USD 678.2 billion. Of this increase, USD 1.4 billion came from the USA. As a result, India's imports from the USA rose from USD 40.8 billion in May to USD 42.2 billion in August, making the USA India's top trading partner with a total trade of USD 119.7 billion, surpassing China," it said.



The Juggernauts defended in numbers for the remaining 20 minutes. Custodian Shreya Hooda also made a couple of remarkable saves in the dving minutes to ensure the win and cap off a historic night in Indian women's football.

The Odisha FC eves displayed tremendous nerves during the game. There were stages they dominated proceedings even though it was an away game for them. They definitely created more chances than their

Earlier in the day, Rakshita, 23, finished last out of four runners in Heat 3 after clocking a timing of 5:29.92s. The two top runners from the three heats qualified for the final. China's Shanshan He topped

Rakshita's heat with a timing of 4:44.66s ahead of Louzanne Coetzee of South Africa, who clocked season best timing of 4:45.25s.

Preethi Pal had won India's first athletics medal in a Paralympics track event Friday, clinching a bronze in the women's T35 100m event with a personal best time of 14.21 seconds.
