## **Growth slows to 2-year low**

India's GDP growing by just 5.4 per cent, its slowest pace in the last seven quarters, has dampened the country's economic outlook at a time when it has already been witnessing a flight of foreign capital. The disconcerting macroeconomic data coming on top of high inflation of over 6 per cent could potentially lead the country to stagflation, an economic condition characterised by slow growth and rising prices. The shocking numbers are also likely to pressurise the Reserve Bank of India, which had been predicting a 7.2 per cent growth for the full year, to ease the high interest rates in its next monetary policy meeting December 6. While the poor performance in the September quarter has been due to a slump in manufacturing and mining sectors, private consumption, which accounts for 60 per cent of the GDP, has also been a drag. Higher food prices, high borrowing cost and weak real wage growth have squeezed urban spending, even as there was some rural recovery on account of the above-average monsoon.

### AGENCIES

New Delhi, Nov 29: India's economic growth slowed to near two-year low of 5.4 per cent in the July-September quarter of this fiscal due to poor performance of manufacturing and mining sectors, data showed Friday.

The GDP had expanded by 8.1 per cent in the July-September quarter of 2023-24 fiscal. The previous low level of GDP growth at 4.3 per cent was recorded in the third quarter

of financial year 2022-23. However, India remained the fastest-growing major economy as China's GDP growth in the September quarter this year was at 4.6 per cent.

According to the National Statistical Office (NSO) data, the growth of agriculture sector GVA (Gross Value Added) accelerated to 3.5 per cent from 1.7 per cent a year ago.

The GVA in manufacturing sector slowed to 2.2 per cent in the second quarter of the current fiscal compared to an

expansion of 14.3 per cent in the year-ago period.

As per the data, the output (GVA) in the 'mining and quarrying' contracted to 0.01 per cent in the second quarter against a growth of 11.1 per cent

a year ago. The expansion in financial, real estate and professional services' GVA was 6.7 per cent, up from 6.2 per cent in the year-ago quarter. Electricity, gas, water supply

and other utility services grew by 3.3 per cent, slower than 10.5 per cent a year ago.





### CONFERENCE CONFERENCE Shah hints at challenges along eastern border to strengthen party

### ESS TRUST OF INDIA

Bhubaneswar, Nov 29: Union Home Minister Amit Shah Friday said security agencies should focus on emerging security challenges along the eastern border, immigration and trends in urban policing.

Inaugurating the annual DGPs/IGPs conference here, which will be discussing a host of emerging national security challenges, including counter-terrorism and left-wing extremism (LWE), Shah congratulated the police leadership for the smooth conduct of 2024 general elections and the seamless rollout of the three new criminal laws.

The focus should be on emerging security challenges along the eastern border, immigration and trends in urban policing, Shah was quoted as saving in an official release.

The Home minister's statement bears significance as India's eastern neighbour Bangladesh has seen unrest following the ouster of its then prime minister Sheikh Hasina and an interim administration taking charge in August.

Bhubaneswar, Nov 29: In a first, researchers from the Central University of Odisha (CUO) have found two Mahseer species - Tor putitora and Tor tor - in Indravati River, a tributary of the Godavari River, in southern Odisha.

According to the team, led by CUO's School of Biodiversity and Conservation of Natural Resources (SBCNR) Dean Professor Sharat Kumar Palita, Mahseer fish species have earlier been reported from the Mahanadi, Brahmani, and Similipal regions of the state.

"It is for the first time they have been reported from any river in southern Odisha, with Tor putitora being a new record for the entire Godavari Basin in India," Palita said.

These two new Mahseer fish species belong to the Cyprinidae family, which are large-bodied and bigscaled carps, often called 'King of the Indian aquatic system' and are included



under 20 mega fishes of the world.

"They inhabit fast-flowing cold, clear, hilly riverine water with pebbly, stony, and rocky bottoms and intermittent rocky pools. They are sacred and worshipped in many Hindu

temples in India," he said. Palita said he began research on Mahseer fish soon after joining CUO around six years ago.

milipal, Mahanadi River System and Brahmani River," he said.

CUO Vice-Chancellor Professor Chakradhar Tripathi and The Vice-Chancellor (I/c) Professor NC Panda congratulated the team, comprising researchers Alok Kumar Naik and Anirban Mahata, for the feat.

The findings were published in the Asian Journal of Conservation Biology.


Globally, Mahseer species belong to three genera - Tor, Neolissochilus, and Nazirtor. Members of the Tor genus are regarded as 'True Mahseer.' There are 17 valid Tor species globally, found in countries like India, China, Bangladesh, Nepal, Sri Lanka, Myanmar, Thailand, Indonesia, Pakistan, and Afghanistan. India now hosts nine species of Tor Mahseer.

With this discovery, Odisha has four recognised Mahseer species - Tor tor, Tor mahanadicus, Tor putitora, and Tor khudree. Locally, these fish are known as 'Kainsari' or 'Khaiser' in Khatiguda area of Nabarangpur, while Bengali communities refer

to them as 'Mahasol.' In India, Mahseer are prized both as game fish and for their culinary value. The Golden Mahseer can grow up to 275cm in length and weigh up to 54kg.

Mahseer is increasingly considered a candidate species for aquaculture due to its sport fishing appeal and excellent flesh quality. However, various human activities such as untreated sewage discharge and pollution have significantlv altered the natural habitats of Mahseer in India, including Odisha.

The IUCN has classified Tor putitora as 'Endangered' and Tor tor as 'Near Threatened,' emphasising the need for conservation efforts.

## **139 customised vehicles** to guard forest divisions

Bhubaneswar, Nov 29: In a significant step to enhance forest fire management and wildlife protection, Forest department deployed 139 specially designed vehicles equipped with advanced features to various forest divisions across the state here Friday, Principal Chief Conservator of Forest (Wildlife) Susanta Nanda flagged off the vehicles in presence of forest officials. These vehicles are intended to combat forest fires, facilitate rescue operations, and patrol remote and inaccessible

Speaking on the occasion, Deputy Conservator of Forest (Administration) Samyak Samantara said that a total of 51 All-Terrain Vehicles (ATVs). 41 customised fire fighting vehicles, and 47 fire support units will be engaged at different forest divisions. "These vehicles are specifically designed to navigate difficult terrains, including hilly and forest regions, where conventional vehicles struggle to reach and carry out emergency operations.'

est divisions across 18 districts Speaking on the occasion, Samantara highlighted that the initiative aims to strengthen fire control measures, ensure better communication, and rescue wildlife in distress.

Joining the event, Princi pal Chief Conservator of Forests and Head of Forest Force Debidutta Biswal, along with Nandankanan Director and additional charge of CCF Wildlife Manoj V Nair emphasised that the vehicles are a crucial part of the department's preparedness for forest fires during the dry season.

The vehicles, provided by Tata Motors and Mahindra, were customised after considering the challenges faced in forest areas. They are equipped to operate in sandy, muddy, and rocky terrains even in 60 degrees inclination. Additionally, the ATVs and fire units are tailored to enhance patrol efficiency and reduce response time during fire incidents.

This deployment marks a significant stride in state's efforts to protect its rich biodiversity and manage forest resources effectively.

Health Survey-V (NFHS 2019-21) report states that nationally 23.3 per cent women between the age group of 20 to 24 were married off before attaining the age of 18 while Odisha reported 20.5 per cent.

"The pain and resilience of millions of girls and mothers, along with the tireless efforts of my colleagues across more than 250 NGOs in the Just Rights for Children alliance, have brought us this historic moment. As we move forward, we look to the government's leadership at state to cultivate a culture where prevention, protection, and prosecution work in harmony and complement each other, leveraging partnerships to drive lasting behavioural change," said JRC founder, Bhuwan Ribhu.

## Rayagada Railway 230 GELATIN STICKS, MAOIST ITEMS RECOVERED IN BOUDH Div a non-starter

Rayagada, Nov 29: With Prime Minister Narendra Modi expected to lay the foundation stone for the long-anticipated South Coast Railway (SCoR) Zone headquarters at Visakhapatnam in Andhra Pradesh soon, the development has reignited discussions over the lack of progress in setting up the Ray agada Railway Division in Odisha, announced back in 2019 by the then Railway Minister along with the SCoR headquarters.

Reports stated that while plans are underway for the prime minister's programme, nothing has moved so far towards setting up of the Railway Division in Rayagada. It is alleged that the delay reflects a systemic neglect of Rayagada region, a concern heightened by the absence of concrete steps, such as building a Divisional office or initiating substantial groundwork. Claiming that the an-

nouncement of the railway division in Ravagada was mere lip service, observers said that the delay was least anticipated given the fact that Union Railway Minister Ashwini Vaishnaw represents Odisha. Moreover, questions are now being raised over the continued neglect of



### BJD concerned over 'Centre's plans'

Bhubaneswar: BJD legislators in the Assembly have expressed concern over the Centre's decision to create the South Coast Railway Zone, a new railway zone with its headquarters in Visakhapatnam, by splitting the East Coast Railway Zone. Raising the issue during Zero Hour Thursday, BJD MLAs Sarada Prasan Jena and Gautam Buddha Das stated that the Union government is planning to split the East Coast Railway Zone and form a new zone by transferring the Waltair Division from East Coast Railway to appease Andhra Pradesh. ### **Missing Deadlines**

he Central Vista project is finally picking up steam, with a buzz around relocating key government ministries to swanky, hightech offices and repurposing the iconic North and South Blocks for something more grandiose. Sources have informed DKB that the Ministry of Finance will be leading this first phase, trading its North Block address for a spot in the new Common Central Secretariat (CCS) complex, alongside over a dozen other ministries. The goal? A seamless transition by March 2025, which means the clock is ticking for babus to pack up their files.

And while all eyes are on this move, there's another project quietly waiting in the wings: the Yuge Yugeen Bharat Museum (YYBM). This ambitious museum is slated to transform the heritage-rich North and South Blocks, presenting a "timeless India" for future generations. But there's a hitch: the Culture Ministry, tasked with building this museum, has been waiting for the handover of these blocks, now expected by mid-2025. This comes after an October 2019 projection, which aimed for a March 2024 finish for the CCS buildings—a deadline that has come and gone, much like a few others in the Vista project.

In the latest round of meetings, it seems officials got a nudge to step up the pace. Apparently, the target is now January for completing the first CCS buildings to allow the big move. As for North and South Blocks, June 2025 is the current deadline for the handover, with conservation work starting soon after. It's a race against time, given the project's ambitious scope and the looming 2029 election year. Clearly, the Centre wants the Vista facelift finished before the next big polls.

### Passing the baton or passing the buck!

The Centre's recent stance on disciplinary authority over IAS and IPS officers is stirring the pot, and it could have some serious ripple effects on Centre-state dynamics. In the Calcutta High Court recently, the Centre made it clear that states, not the Department of Personnel and Training (DoPT), have the power to take action against officers serving within their borders. This statement came in response to a petition against former Kolkata Police Commissioner Vineet Goyal, who allegedly revealed the victim's name in a high-profile case.

According to the Ministry of Home Affairs' circular last month, the Additional Solicitor General informed the bench that states have jurisdiction when it comes to holding IAS, IPS, or IFS officers accountable for any misconduct. This clarification shifts the burden to states, essentially sidestepping the Centre from the responsibility—a move that some might see as "passing the buck."

But this isn't just about one case or one officer. It's a reflection of a broader trend, as states increasingly push back on what they see as Centre-led overreach. With this new position, the Centre seems to be



inviting states to take on greater responsibility, potentially leading to a fractured approach in the way bureaucratic discipline is enforced across India. For example, some states may be tougher or more lenient than others, setting up a patchwork of standards that could make officers wary about which state they're posted in next. And, let's be honest, it also opens the door for states to exert a bit more political leverage when it comes to "disciplining" officers who may not be playing by local rules.

As the Centre and states continue this dance over authority, one thing's for sure: the ground rules of Centre-state relations are quietly being rewritten. Whether this ends up fostering more collaboration or leads to more tussles is something to keep an eye on.

### **Project delays or a play of timing?**

In a surprising move, a senior IAS officer, holding a prestigious post since June 2021, was abruptly sidelined just a month before retirement. Officially, his removal was attributed to project delays, but the timing of this bureaucratic shake-up has left many raising their eyebrows. Along with this officer, nine others found themselves reassigned, sparking speculation about what's really behind this shuffle.

Here's where it gets interesting: the key official who could have influenced this decision-a batch mate of the officer in questionwas absent on the day it all went down. Many believe that if this individual had been around, perhaps the outcome would've been different, sparing the officer from being placed on a waitlist so close to retirement. So, was it all about project delays, or did timing play a crucial role here? The officer's abrupt removal right before retirement, combined with the absence of an influential colleague, suggests there's more to the story. It's not uncommon for bureaucracy to be as much about timing and relationships as it is about performance. For now, though, all we can do is wait and watch—until the next chapter in this ongoing saga unfolds.

## **CHANGE FARM PRACTICES**

ealthy soil is indispensable to life on Earth, sustaining nearly 60% of all living species. As the second-largest carbon reservoir after oceans, soil is also among our planet's most important natural assets in the fight against climate change.

But the world's soils are un-

Droughts are increasingly turning fertile land into deserts, while pesticide use drastically reduces soil biodiversity, threatening our ability to produce healthy food. As high-quality agricultural land becomes scarcer, conflicts over shrinking topsoil- critical for crop growth - are intensifying.

The Heinrich Böll Foundation's recent Soil Atlas highlights the many ways we are losing the ground beneath our feet. The current industrial agriculture system has been a major driver of soil degradation, accelerating biodiversity loss and depleting vital carbon reserves. Yet despite its impact, the agriculture sector has made little progress in advancing climate goals. Its global greenhouse gas emissions have remained largely unchanged over the past decade.

As countries worldwide set new emissions-reduction targets under the 2015 Paris climate agreement, it is clear that achieving real emissions cuts will require developing strategies to reduce the agriculture sector's carbon footprint.

One approach touted as a potential solution is 'carbon farming,' which uses market incentives to reward farmers for storing carbon in their soil. By adopting practices like planting cover crops, farmers can earn certificates for increasing carbon storage. These certificates can then be sold as carbon credits in voluntary or government-mandated markets, providing farmers with an additional income stream.

This concept has gained traction in both public-policy circles and the private sector. Fertilizer and pesticide companies like Yara and Bayer have already rolled out their own certification programmes, while major agriculture producers such as Canada and Australia have integrated these credits into their markets. The European Union is also developing a certification programme for carbon farming, and global carbon markets are expected to follow suit.

Unfortunately, the newfound popularity of carbon farming risks perpetuating the false notion that emissions reductions and soil carbon storage are interchangeable. Even if we accept this premise, developing a system to offset emissions through carbon storage is extremely difficult. For such a system to be effective, storage must originate from a change in farm practices and be measurable and secure for at least a century.

But given that carbon stored in soils is inherently unstable and can easily be

re-released into the atmosphere by droughts, floods, or shifts in farming practices, long-term storage remains highly unreliable.

Previous attempts to address this instability in other natural reserves have been unsuccessful. For example, reserve credits set aside to offset unintended carbon releases from forests in California are being depleted faster than anticipated after the intense wildfires there. And there has been little interest in credits with expiration dates, which would require buyers to renew them periodically

While it is possible to measure the carbon stored in soil, doing so is neither simple nor cheap. The accuracy of these measurements depends on several factors, including sampling depth, location, and timeframe. Alternative methods, based on limited sampling or mathematical models, have failed to overcome measurement challenges.

Since prices for soil-carbon credits have been too low to cover the costs of changing

agricultural practices, farm ers are unlikely to embrace them. In response, European regulators have opted to make credit generation easier, rather than adjusting price incentives, thus compromising the system's integrity.

methodological Beyond challenges, carbon farming can serve as a smokescreen for the livestock industry. Industry groups claim that carbon storage in grasslands can offset methane and nitrous-oxide emissions. But this scenario is unrealistic, given that it would require vast amounts of grassland. It is well established that the most effective way to reduce livestock emissions is to cut livestock numbers and consumption of meat and dairy.

The carbon-market approach views maintaining soil health and reducing emissions as an either/or choice. In reality, both are necessary, as healthy soil is essential for food production. The Intergovernmental Panel on Climate Change has found that sequestering carbon in soils – or anywhere else – cannot replace emissions reductions. Targeting emissions reductions, rather than relying solely on soil credits, could have the additional benefit of weakening the appeal of controversial technologies that aim to remove carbon from the atmosphere.

Simply put, a market-based approach to carbon storage cannot deliver the transformative change we need. We cannot offset our way out of the climate crisis. Instead, we should redirect public funds currently spent on agricultural subsidies to investments that improve soil health and support farmers as they undertake the transition to a climate-resilient food system. 28% of Ukrainian land.

The question staring at the whole world is how to end this war. On India's perspective on the war, New Delhi has been maintaining from day one that the conflict could not be solved on the battleground; it can only be done through dialogue and diplomacy, in other words, negotiation. But can you negotiate with a lion when your head is in its mouth? That raises a practical question on the efficacy of diplomacy when there is an obvious power disparity.

We will do well to recall that negotiation between two blocs was possible when there was a balance of power between the USA and the Soviet Union. That is how the world experienced several negotiations on arms control and disarmament, etc.

In the case of Ukraine, where a full-blown war goes unabated, is there any prospect for negotiation? The terms of negotiation are sub-

dom is ready to fight on the side of Ukraine at any time. So, it is not out of order for the West to come out openly. It will not lead to a Third World War more than it is now. The Ukrainian war will not draw China, another military and economic power, to make it a world war. Unless Russian President Putin is made to realise that he cannot win and can only self-destruct, he may not agree to the terms set by Ukraine and its supporters. Russia has to vacate the land it has taken from Ukraine after February 2022 if not after the annexation of Crimea.

Coming back to diplomacy, no dialogue is feasible if there is a big gap in power of deterrence among the negotiating parties. A bipolar world is conducive to negotiation between somewhat equal powers. Such a scenario is emerging-the Global West on one side and China-Russia on the other, the Global South choosing either of the sides

Yes, diplomacy should win and war as a strategy must lose. But for diplomacy to succeed, the countries should show the collective capacity that they are ready for a war. The writer is Secretary


### Canine menace on rail platforms

As the inauguration of the temple marked the culmination of a decades-long campaign, mostly under the Hindutva banner, to reclaim a disputed religious site in Ayodhya, Modi said it was the advent of a new era.

New Delhi, Nov 29: India Friday said the interim government in Bangladesh must live up to its responsibility of protecting all minorities as it expressed serious concern over the "surge" of extremist rhetoric and increasing incidents of violence against Hindus as well as attacks on temples in the neighbouring country.

New Delhi also hoped that the case relating to Hindu monk Chinmov Krishna Das. arrested in Bangladesh on sedition charge, will be dealt with in a just, fair and transparent manner. External Affairs Minister S Jaishankar told Parliament that India has taken a serious note of incidents of violence against minorities in Bangladesh and that it is the primary responsibility of Dhaka to protect the life and liberty of all the citizens, including minorities.

Jaishankar said that following these attacks the Bangladeshi government had issued instructions for providing special security including deployment of Army and border guards to ensure a peaceful Durga Puja celebrations.

On the arrest of Das, who was associated with the ISKCON (International Society for Krishna Consciousness), Jaiswal said it is India's expectation that a fair and transparent trial will be ensured in the case.







London: Louise Haigh resigned as Britain's transport secretary Friday after revelations that she pleaded guilty to a criminal offence before becoming a Member of Parliament. Police in the Chinese capital detained the 62-yearold former Guangming Daily editor and journalist in February 2022 while he was lunching with a Japanese diplomat, the US National Press Club said in a statement. He was later charged with espionage. "Sentencing Yuyu to seven years in prison on no evidence declares to the world the bankruptcy of the justice system in China," Dong's family said in a statement.

### **Russian defence min visits North Korea**

Seoul: Russian Defence Minister Andrei Belousov arrived in North Korea Friday for talks with North Korean military and political leaders as the countries deepen their cooperation over Russia's war in Ukraine. In announcing the visit, Russia's Defence Ministry didn't say whom Belousov would meet or the purpose of the talks. North Korean

state media didn't immediately confirm the visit. Belousov, a former economist, replaced Sergei Shoigu as defence minister in May after Russian President Vladimir Putin started a fifth term in power. Photos released by the Defense Ministry showed Belousov walking alongside North Korean Defense Minister No Kwang Chol on a red carpet at a Pyongyang airport. ### Footprints show two ancient human species crossed paths

A new study describes ancient footprints from the species Homo erectus and **Paranthropus boisei** that were left near a lake in Kenya within hours or days of one another

Kenya, Nov 29: About 1.5 million years ago, individuals of two different species in the human evolutionary lineage trudged on a muddy lakeshore in northern Kenya, leaving behind intersecting trackways alongside the footprints of an-

storks and other animals. These tracks turned into fossils that scientists have now discovered at a location called

telopes, horses, warthogs, giant

Koobi Fora, providing the first evidence that these two species, Paranthropus boisei and Homo erectus, shared the same landscape, literally crossing paths. The discovery raises intriguing questions about the relationship between the two species and any competition

for resources. Paranthropus boisei, the more distantly related to modern humans of the two, lived from about 2.3 to 1.2 million years ago, standing up to about 137 cm tall. They had a skull adapted for large chewing muscles, including a cranial crest like those in male gorillas, as well as massive molars. Their feet bore ape-like traits including in the big toe.

Homo erectus, an early member of our evolutionary line with body proportions like those of Homo sapiens, lived from about 1.89 million to 110,000 years ago, ranging from about 145-185 cm tall. They had large brow ridges and big-

ger brains than Paranthropus boisei, though smaller than our species.

The researchers found the footprints in 2021 in the vicinity of Lake Turkana. They identified one long trackway of 12 footprints, each about 26 cm long, attributed to an adult Paranthropus boisei individual based on their shape and the manner of locomotion.

The researchers said the trackways appear to have been left within hours or perhaps a couple of days, the mud had never dried and cracked and the individuals even may have seen each other. There was no evidence of interaction.

'The fossil footprints provide us a clear picture of that instant in time, 1.5 million years ago. The different human ancestors may well have passed by each other, wading in the shallow water, possibly hunting and gathering," said paleoanthropologist Louise Leakey, director of the Koobi Fora Research **Possibly a direct** ancestor of Homo sapiens, Homo erectus was the first human species to spread beyond Africa

Project and co-author of the study published Thursday in the journal Science.

The researchers reanalysed trackways that were previously discovered nearby, determining that both species were present together on fossilised muddy surfaces over a period spanning roughly 200,000 years.

"It is possible that they competed directly, but also possible that they were not in direct competition and both had access to the resources that they needed on this shared landscape," said paleoanthropologist and study lead author Kevin Hatala of Chatham University in Pittsburgh.

### **Russian drone** attacks damage buildings in Ukraine

Kyiv, Nov 29: Russian drone attacks on Ukraine injured at least eight people and damaged residential buildings in the capital Kyiv and in the southern Odesa region overnight, officials said Friday

Ukraine's air force said in a statement that, of 132 drones launched against the country overnight, it had downed 88 drones, while 41 were "lost" likely due to electronic warfare and one returned to the Russian territory.

Russia has stepped up its nightly drone attacks on Ukrainian cities as it continues to push along the eastern frontline, making some of its largest monthly territorial gains since 2022. It launched a record-high number of 188 drones against the country Tuesday before staging a large-scale attack on Ukraine's power grid Thursday.

## **Fiscal deficit hits 46.5 pc** of full-year target in Oct

### PRESS TRUST OF INDIA

New Delhi, Nov 29: The Centre's fiscal deficit at the end of the first seven months of financial year 2024-25 touched 46.5 per cent of the full-year target, government data showed Friday.

In absolute terms, the fiscal deficit -- the gap between government's expenditure and revenue -- was at ₹7,50,824 crore during April-October period, according to data released by the Controller General of Accounts (CGA).

The deficit stood at 45 per cent of the Budget Estimates (BE) in the corresponding period of 2023-24

In the Union Budget, the government projected to bring down the fiscal deficit to 4.9 per cent of gross domestic product (GDP) in the current 2024-25 financial year. The deficit was 5.6 per cent of the GDP in 2023-24.

In absolute terms, the government aims to contain the fiscal deficit at ₹16,13,312 crore during the current fiscal.

The revenue-expenditure data of the Union government for the first seven months of 2024-25 showed that the net tax revenue was about ₹13 lakh crore or 50.5 per cent of budget estimate for the current fiscal.

The net tax revenue collection was 55.9 per cent at September-end of 2023.



The Central government's total expenditure in the seven months through October stood at ₹24.7 lakh crore or 51.3 per cent of budget estimate. Expenditure was 53.2 per cent of budget estimate in the year-ago period.

Of the total expenditure, ₹20 lakh crore was in the revenue account and ₹4.66 lakh crore in the capital account.

Commenting on the data, Aditi Nayar, Chief Economist, ICRA, said the government of India's fiscal deficit compressed to ₹7.5 lakh crore or 46.5 per cent of the FY25 BE in April-October FY25, from ₹8 lakh crore in April-Oct FY24. led by the RBI's dividend payment as well as the continuing YoY contraction in the capital

### Govt mulls change Banks' credit to industry in base year for **GDP** computation

New Delhi, Nov 29: The government is considering changing the base year for computation of the GDP to 2022-23 in February 2026 to reflect an accurate picture of the economy a top government official said. This will be the first revision in over a decade. It was last done in 2011-12.

Addressing an event here, Ministry of Statistics and Pro gramme Implementation (Mo-SPI) Secretary Saurabh Garg further said the ministry will come up with monthly estimates of Periodic Labour Force Survey (PLFS) from January next year.

"Next base year (GDP) will be 2022-23 ... will be implemented from February 2026," Garg said.

The 26-member Advisory Committee on National Accounts Statistics (ACNAS), which was constituted under the chairmanship of Biswanath Goldar, is expected to complete the exercise by early 2026.

Regularly updating the base year is essential to ensure that indices accurately reflect changes in the economy's structure, such as shift in consumption pattern, sector weight and the incorporation of new sectors.

Mumbai. Nov 29: The rupee plunged 13 paise to settle at a fresh all-time low of 84.60 against US dollar Friday, dragged down by unabated foreign fund outflows even as weak domestic macroeconomic data jolted the overall sentiment.

Forex traders said, dollar demand from importers for meeting month-end pavment obligations weighed on the rupee, while, the GDP data released by the government later in the day adversely impacted the currency market, toppling the local unit to its record low.

The latest government data released Friday showed India's economic growth slowed to near two-year low of 5.4 per cent in the July-September quarter of this fiscal due to poor performance of manufacturing and mining sectors as well as weak consumption.

The gross domestic product (GDP) had expanded by 8.1 per cent in the July-September quarter of 2023-24 fiscal and 6.7 per cent in first quarter of current fiscal (April-June 2024).

The previous low level of GDP growth at 4.3 per cent was recorded in the third quarter (October-December 2022) of financial year 2022-23.




